

TERMS AND CONDITIONS GOVERNING UOB WIN A TRIP TO ANYWHERE LUCKY DRAW

1. Eligibility

- 1.1. United Overseas Bank Limited ("UOB") has the absolute discretion to determine the eligibility of any person who is interested to participate ("Participant") in the UOB Win A Trip To Anywhere Lucky Draw ("Lucky Draw"). Such determination shall be final and conclusive and UOB is not obliged to give any reason therefor.
- 1.2. The following persons shall not be eligible to participate in the Lucky Draw:
 - 1.2.1. Directors and employees of UOB and UOB Travel Planners Pte Ltd (UOBTP);
 - 1.2.2. Employees of the advertising, promotion agencies and any other persons involved in organizing, promoting and/or conducting the Lucky Draw;

 - 1.2.4. Persons who cancel their travel bookings with UOB Travel Planners within the Lucky Draw period.

 - 1.2.6. Any other person deemed ineligible at the sole discretion of UOB.

2. Qualifying Period

- 2.1. "Qualifying Period" for the Lucky Draw means the period commencing 01 September 2010, 0000hrs to 31 December 2010, 2359hrs (both dates inclusive).
- 2.2. UOB reserves the right to change the Qualifying Period of the Lucky Draw.

3. Qualifying Online Transactions and Allocation of Lucky Draw Chances

- 3.1. The Participant will be allotted one (1) lucky draw chance for the Qualifying Online Transactions performed during the Qualifying Period.

	3.2.7.2 Participant must perform the application via UOB Personal Internet Banking, print and submit the signed application form to the bank for approval.
	3.2.7.3 One (1) Lucky Draw chance will be allotted for each approved Incoming Funds Transfer arrangement.

- 3.3. UOB's records of transactions and the total number of 'Qualifying Online Transactions' allotted to Participants shall be final and conclusive. Without limiting the generality of this provision, UOB shall not be liable for any error or omission in the record of transactions or selection of winners for the Lucky Draw.
- 3.4. Lucky Draw chances allocated during the Qualifying Period are not transferable.



3.5. Chance(s) accumulated within the month cannot be brought over to the following months' Lucky Draw. In the event that a Particpant wins in a particular month, he/she can still participate in the following months' Lucky Draw provided he/she performed the Qualifying Online Transactions during the Qualifying Period.

4.6. UOB reserves the right to draw reserve winners to substitute any winner subsequently found to be disqualified. UOB's determination of the winners shall be final, conclusive and binding. No correspondence or claims will be entertained.

 - 5.6.6. Other tour, airline or hotel booking terms and conditions apply.
- 5.7. Prizes are neither transferable nor exchangeable for cash, credit or kind, in full or in part.
- 5.8. UOB assumes no liability or responsibility for the acts or defects in the goods or services offered in this Lucky Draw. UOB is not an agent of the merchant or service provider. Any dispute about the quality or service standard must be resolved directly with the merchant or service provider. The merchant or service provider may impose conditions for the redemption of the goods or services. UOB will not be responsible for any injury, loss or damage suffered as a result of the redemption or usage of the

- 7.3. In the event of any inconsistency between these terms and conditions and any advertising, promotional, publicity and other materials relating to or in connection with the Lucky Draw, these terms and conditions shall prevail.

7.6. These terms and conditions shall be governed by and construed in accordance with the laws of Singapore, and all Participants who participate in the Lucky Draw shall be deemed to have agreed to submit to the exclusive jurisdiction of the Singapore Courts.
