

WIN S\$1,000 WORTH OF EPICENTRE VOUCHERS LUCKY DRAW
TERMS AND CONDITIONS

Eligibility

- 1.1 The UOB Overseas Bank Limited ("UOB") Win S\$1,000 worth of EpiCentre vouchers at EpiCentre @ Orchard & Suntec ("EpiCentre") Lucky Draw ("the Draw") is open to all eligible UOB Credit Card customers as herein described.
- 1.2 Subject to the provisions herein and in particular, Rule 1.3, "Eligible Customers" shall mean all UOB Credit Card accounts of UOB (collectively referred to as "Accounts") which are valid, subsisting and in the opinion of UOB in good standing.
- 1.3 Notwithstanding anything herein, UOB has the absolute discretion at any time and from time to time to determine the eligibility of any customers and shall not be obliged to give any reason therefore. Without limiting the generality of this provision, Eligible Customers:
 - i. who are staff or Directors of United Overseas Bank Ltd and EpiCentre @ Orchard & Suntec during the Period (as hereinafter defined);
 - ii. whose principal Account(s) is/are terminated between [20 July 2007] and the Draw Date (both dates inclusive);
 - iii. who are deceased or who face legal incapacity;
 - iv. who face legal proceedings or any threat of legal proceedings;
 - v. whose accounts are otherwise determined by UOB in its absolute discretion as being delinquent or unsatisfactorily conducted for any reason;
 - vi. At any time before the Draw Dates shall be disqualified and shall not be entitled to any payment or compensation whatsoever, even if he or she has been selected to be the winner of the Draw.

Dates

- 5.3 The winner's name and NRIC No will be published on the UOB website within one month from the date of the draw.
