We represent and warrant that all information provided by us in this application and in any other document is complete, true and accurate and undertake that in the event any of the information provided by us becomes inaccurate or misleading or changed in any way we shall promptly notify the Bank of any such changes in writing. AGREEMENT TO USE COMPANY'S NAME/LOGO/MARK

- In this Agreement, unless the context otherwise requires and unless otherwise provided in this Agreement and the prevailing "UOB Business Debit Cardmembers Agreement", the following words and expressions shall have the meanings respectively set out below:-
 - Agreement* means this agreement between the Bank and the Cardmember as may be varied from time to time;
 "Application" means the Bank's prescribed form for the issuance of a customised or, where applicable, a non-customised Card;
 - "Bank" means United Overseas Bank Limited and shall include its successors and assigns:
 - "Design" means the name and/or logo and/or mark of the Cardmember in such form and designs selected by the Cardmember and agreed by the Bank; "Card" means a UOB Business Debit Card or any other debit card issued by the Bank and a replacement or renewal thereof;

 - "Cardmember" means the applicant named in the Application, particulars of which are set out in the Application; and
- g. "Cardwest" means the Carduser named in the Application and any person nominated or authorised by the Cardmember from time to time, and acceptable to the Bank, to use the Card. The Bank shall provide the Carduser, without any charge or fee, such Application Forms.

 The Cardmember shall use its best endeavor to promote the Cards to the Cardusers and make available the Application to the Cardusers.
- The Bank may reject any Application submitted without giving any reason. The Bank will not enter into correspondence about such decisions.
- Subject to Clause 6, all customised Cards issued to Cardusers by the Bank shall bear the Design of the Cardmember.

The Cardmember agrees to fully indemnify and hold the Bank harmless against any actions, demands, liabilities or claims arising or loss or damages or costs of any kind suffered by the Bank as a result of the Design being used on the Pre-Designed Card and/or the Customised Logo Card or any promotional material or other documents in relation to the Cards, or in respect of the Bank storing, copying or using the Design.

 The Cardmember hereby irrevocably agrees that the Design has been agreed upon between the Bank and the Cardmember and that the Bank shall not be held liable in any way whatsoever if the Design on the Customised Logo Card or the Pre-Designed Card if the Cardmember shall be solely responsible for any changes required to the Design on the Customised Logo Card or the Pre-Designed Card if the Cardmember is not satisfied with the same and wishes to make any changes.
- The Cardmember unconditionally and irrevocably consents to the use by the Bank, free of all charges or fees, of the Design on the Cards or any promotional material or other documents in relation to the Cards.
- The Cardmember unconditionally and irrevocably consents to the use by the Bank, free of all charges or fees, of the Design on the Cards or any promotional material or other documents in relation to the Cards.

 Upon request by the Bank, the Cardmember shall certify in writing as to any information relating to a Carduser and the person named in the Application as the Carduser is under the employment of the Cardmember, and if so, the position held and the salary drawn by such person in the employ of the Cardmember.

 All fees and charges payable under this Agreement are of such amounts and/or levied at such rates as the Bank may determine at its absolute discretion and are subject to change by the Bank at any time and from time to time without notice and without giving any reason. The Bank reserves the right to levy any fee or charges for any service provided or any action taken by the Bank in relation to or in respect of this Agreement.

 This Agreement may be terminated by either the Bank or the Cardmember by giving one month's prior written notice to the other party and if this Agreement is terminated, the Cards issued at the request of the Cardmember shall be terminated by the Bank. The obligations and liabilities of the Cardmember under this Agreement shall continue notwithstanding the termination of this Agreement by either party for any reason.

 The Customised Logo Card or Pre-Designed Card issued by the Bank to the Carduser remains the property of the Bank and the Cardmember agrees to immediately return it or destroy it if asked, or if the Customised Logo Card or the Pre-Designed Card or account that the Customised Logo Card or Pre-Designed Card belongs to is cancelled or closed.

 The Cardmember shall indemnify and keep the Bank fully indemnified against any loss, damage, liability, cost and expense which the Bank may suffer or incur (including legal costs on an indemnity basis) arising out of or in connection with this Agreement, including without limitation, the use of the Design.

- In addition to and without prejudice to the terms relating to the Bank's rights of disclosure under the prevailing "UOB Business Debit Cardmembers Agreement", the Cardmember consents that the Bank may at any time and without notice or liability disclose to any person as the Bank deems ft (including without limitation, any Visa Worldwide/MasterCard International; any of the Bank's branches (wheresoever situate), its agents, servants, correspondents, independent contractors and/or associates; and any bank or financial institution) such information of or relating to the Cardmember whenever the Bank considers it in its interest to make such disclosure.

 No forbearance or failure or delay by the Bank in exercising any right, power or remedy shall be deemed to be a waiver of any subsequent breach of the same or any other provision of this Agreement.

- This Agreement shall be governed by the laws of Singapore. The Cardmember hereby submits irrevocably to the exclusive jurisdiction of the courts of Singapore.

 In the event this Agreement is terminated for any reason whatsoever, the Customised Logo Card and the Pre-Designed Card of the Cardmember shall be replaced without any Design and any and all fees, charges or expenses paid or payable prior to such termination will not be refunded or waived.
- The customised Card service is subject to the terms and conditions of this Agreement as well as the prevailing "UOB Business Debit Cardmembers Agreement". In the event of any inconsistency, the terms and conditions in the prevailing "UOB Business Debit Cardmembers Agreement" will apply.
