

UOB Personal Internet Banking Get Mobile! Promotion #1 - Free USB Mobile Phone Charger Terms and Conditions

- 1. The United Overseas Bank Limited ("UOB") Personal Internet Banking 'Get Mobile! Promotion #1 Free USB Mobile Phone Charger' ("the Promotion") is open to all Eligible Customers as herein described.
- 2. Eligible Customers refer to all Campus and TX customers of UOB who maintain a Personal Internet Banking ("PIB") Account and who, during the Qualifying Period (defined in 4) fulfill the conditions as listed in 5.
- 3. Employees of UOB, FEB, advertising agencies and anyone directly connected with the promotion are not eligible. Notwithstanding anything herein, UOB has the absolute discretion at any time and from time to time to exclude an otherwise Eligible Customer and shall not be obliged to give any reason therefor.
- 4. The Qualifying Period for the Promotion is from Thursday, 15 September 2005 at 0000 hours to Monday, 31 October 2005 at 2359 hours.
- 5. An Eligible Customer who performs a successful telecommunication bill payment online with a minimum transaction amount of S\$20, at UOB Personal Internet Banking during the Qualifying Period will be entitled to one (1) USB Mobile Phone Charger* ("the Prize").

- 7. Eligible Customers who have terminated their UOB PIB within 6 months prior to the Qualifying Period will not be eligible for the Prize when they re-apply for UOB PIB during the Qualifying Period.
