<u>Terms & Conditions Governing the United Overseas Bank Limited Caltex "Win a \$5</u> petrol voucher" Promotion (18 March – 30 April 2015) ("Promotion")

Terms and conditions:

- 1. This Promotion is valid from 18 March 2015 to 30 April 2015, both dates inclusive ("Promotion Period").
- 2. This Promotion is only open to United Overseas Bank Limited ("UOB") Credit and Debit Cardmembers ("Eligible Cardmembers") who have made a minimum \$60 nett petrol spend ("Eligible Transactions") at any Caltex service station in Singapore during the Promotion Period.
- 3. Every 20th Eligible Transaction made islandwide will be entitled to a UOB terminal generated \$5 return voucher on an original charge slip ("**Voucher**") which can be used in the next transaction.
- 4. The Voucher is redeemable with a minimum \$60 gross petrol purchase (before UOB discount and any applicable site discount) in a single receipt at all Caltex service stations in Singapore.
- 5. The Voucher is valid for seven (7) days from date of issuance (date on the charge slip).
- 6. The original Voucher must be presented at time of payment and payment to be made with a UOB Credit or Debit Card.
- 7. Vouchers that are defaced or damaged will be rejected and the Eligible Cardmembers will not be entitled to redeem the Voucher.
- 8. Caltex site discount and UOB discount shall be applied after deduction of the Voucher's value. The Voucher cannot be used in conjunction with any other discount, privileges or promotions unless otherwise expressly stated by UOB or Chevron Singapore Pte. Ltd. ("Chevron").
- 9. Only one (1) Voucher may be used for each petrol purchase or transaction.
- 10. The Voucher is not redeemable for cash or subject to cash out facilities. There will be no revalidation or exchange for expired Vouchers.
- 11. UOB and Chevron are not obligated to replace a damaged voucher and reserve the rights to confiscate or refuse to honour a Voucher which it suspects to be counterfeited or tampered with.
