

Terms & Conditions Governing the United Overseas Bank Limited Caltex Collectibles Promotion (1 September 2014 – 31 December 2014) ("Promotion")

- 1. This Promotion is valid from 1 September to 31 December 2014, both dates inclusive ("Promotion Period").
- 2. This Promotion is only open to United Overseas Bank Limited ("UOB") Credit and Debit Cardmembers ("Eligible Cardmembers") who have collected a total of four (4) Promotion stamps ("Stamp") on a Promotion redemption card ("Redemption Card"), each to be collected at a Caltex service station in Singapore ("Caltex Station"), within one (1) calendar month.
- 3. To collect one (1) Stamp, Eligible Cardmembers must charge a minimum of S\$70 gross on petrol on a UOB Credit or Debit Card and present the Redemption Card, at the point of payment, at any Caltex Station during the Promotion Period. Limited to one (1) Stamp per transaction, regardless of value of transaction.
- 4. Eligible Cardmembers who have collected a total of four (4) Stamps within the same calendar month can redeem one (1) Caltex gift for the relevant month, as determined by UOB, worth S\$19.90 ("Collectible"). The Collectible for the month must be redeemed by the Eligible Cardmembers before the end of the relevant calendar month. Any unredeemed Stamps collected in a calendar month shall expire at the end of the relevant month and shall no longer be capable of redemption.
- 5. Redemption of Collectibles is available from 15 September onwards, on a first-come, first-served basis, are while stocks last and are not exchangeable for credit, cash or kind by the Eligible Cardmember.
- 6. UOB reserves the right, at its discretion, at any time, without notice or assigning any reason thereof, replace or substitute the Collectibles with any other gift of equal or similar value. Chevron Singapore Pte. Ltd. ("**Chevron**") assumes no liability or responsibility to any Eligible Cardmember relating to UOB's exercise of its rights of this clause.
- 7. Each Eligible Cardmember is limited to redeem only one (1) Collectible per month under this Promotion notwithstanding that the total gross spend charged to his/her UOB Credit or Debit Card at Caltex Stations or total Stamps collected is more than S\$280 or four (4) stamps per month respectively.
- 8. If UOB subsequently discovers that the Eligible Cardmember has redeemed more than one (1) Collectible in the month of Promotion or any of the conditions herein is not fulfilled, UOB may at its discretion charge the full retail value of the Collectible(s) redeemed. No person shall be entitled to any payment or compensation from UOB should UOB exercise its discretion to forfeit or reclaim any Collectible.
- 9. No replacement will be made for damaged or lost Collectibles.
- 10. This Promotion shall not apply in conjunction with any other offers, discounts, privileges or promotions unless otherwise stated herein.
- 11. Collection of Stamps and redemption of Collectibles is not valid for purchases made using Cabbie21, Diesel Programme, Caltex StarCard or StarCash card.
- 12. UOB and Chevron are not agents of the merchant, supplier or manufacturer of the goods and services offered in this Promotion. Therefore, UOB and Chevron assume no liability or responsibility for the acts or defaults of the merchant, supplier or manufacturer or defects in the goods and services offered.
