Terms and Conditions Governing the Rugby World Cup 2015, UOB PRVI Miles World MasterCard Lucky Draw

Eligibility

- The Rugby World Cup 2015 United Overseas Bank ("UOB") PRVI Miles World MasterCard Lucky Draw ("the Draw") is open to Eligible Cardmembers (as defined below), subject to the following terms and conditions ("Terms and Conditions"). Participation in the Draw is deemed acceptance of these Terms and Conditions.
- Subject to the provisions herein, "Eligible Cardmembers" shall mean all existing and new principal holders of UOB PRVI Miles World MasterCard credit cards issued in Singapore which are valid, subsisting and in the opinion of UOB in good standing and satisfactorily conducted.
- 3. Without limiting the generality of the above, the following persons shall not be eligible for the Draw:
 - (a) directors or employees/ staff of UOB, MasterCard Inc, Rugby World Cup Limited ("RWCL"), or any of their respective subsidiaries during the Qualifying Period (as defined below) and their respective immediate family members;
 - (b) employees and staff of any other auditors, advertising agency, promotion agencies and/or other persons involved (directly or indirectly) in organizing, promoting and/or conducting the Draw and their immediate family members;
 - (c) persons whose principal UOB PRVI Miles World MasterCard credit card(s) is voluntarily or involuntarily cancelled, terminated, closed or suspended at any time on or during the Qualifying Period or Draw Dates (as defined below);
 - (d) persons who are or have become mentally incapacitated, deceased, insolvent or who face legal incapacity; or
 - (e) persons who face legal proceedings of any nature or any threat of legal proceedings of any nature being instituted against them.
- 4. Notwithstanding anything herein to the contrary, UOB has the absolute discretion at any time and from time to time to determine the eligibility of any UOB PRVI Miles World MasterCard credit cardmember to participate in the Draw and shall not be obliged to give any reason therefore.
- 5. For the avoidance of doubt, the termination of a supplementary UOB PRVI Miles World MasterCard cardmember of an Eligible Cardmember's account will not by itself disqualify the Eligible Cardmember from the Draw.

Lucky Draw - Entry

- 6. "Qualifying Period" for the Draw means the period commencing at 00:00hrs (GMT +8) on 5 May 2015 to 23:59hrs (GMT +8) on 30 June 2015.
- 7. The chances for the Draw shall be allocated in the following manner:-
 - (a) One (1) chance will be allocated to every Eligible Cardmember for every Eligible Transaction made in Singapore dollars (as defined below) during the Qualifying Period; and
 - (b) Two (2) chances will be allocated to every Eligible Cardmember for every Eligible Transaction made in foreign currencies during the Qualifying Period. The calculation of the amount of Eligible Transaction made in foreign currencies is based on UOB's then prevailing exchange rate conversion of the foreign currency into Singapore dollars. Foreign currencies are currencies other than the Singapore dollar.

8. "Eligible Transaction" means a transaction amounting to Singapore Dollars \$100 or more which is charged to a UOB PRVI Miles World MasterCard credit card (including Installment Payment Plan payments). Funds transfers, cash advances, fees, interests, any other financial charges and any other transaction as UOB may state from time to time will not qualify as Eligible Transactions.

Eligible Transaction made during the Qualifying Period must be posted and captured in UOB's system during the Qualifying Period to qualify for the Draw.

UOB is not responsible to ensure that the Eligible Transaction are posted promptly and shall not be responsible for any failure or delay in the transmission of evidence of sales transactions by merchant establishments, postal or telecommunication authorities or any other party(s) which may result in an Eligible Transaction being charged by the Eligible Cardmember and/or his/her supplementary credit cardmember(s) being omitted from the allocation of chances by UOB during the Qualifying Period.

- 9. Subject to these Terms and Conditions, there is no limit set to the number of chances an Eligible Cardmember may accrue for the Draw during the Qualifying Period.
- 10. Eligible Transaction made by a supplementary cardmembers shall accrue to the benefit of the Eligible Cardmember for the purpose of the Draw.
- 11. Draw chances awarded to Eligible Cardmembers are not transferable.
- 12. UOB reserves the right, at its absolute discretion, to effect any adjustments, forfeitures or disqualification of the chances allocated for the Draw. UOB's determination of the allocation hall be final and conclusive. No correspondence or claims will be entertained. Lucky Draw Draw Date and Prizes
- 13. Unless UOB notifies otherwise, the Draw will be conducted on 14 Aug 2015, at 11:00hrs (GMT +8) at 480 Toa Payoh Lorong 6 #25-01 HDB Hub East Wing Singapore 310480 in the presence of external auditors or on such other date or time or at such other venue as may be determined by UOB at its sole discretion.
- 14. There shall be three (3) prize winners of the Draw (each, a "Winner"). Courtesy of MasterCard, each Winner shall receive the following prize package (the "Prize"):-
 - (a) Two (2) Economy Class return air tickets to London;
 - (b) Meet-and-greet service upon arrival at the London airport;
 - (c) Four (4) day/ three (3) night luxury accommodation for two (2) in London;
 - (d) Welcome Reception;
 - (e) Two (2) Category A tickets to Rugby World Cup Match on 24 Oct 2015;
 - (f) Two (2) Category A tickets to Rugby World Cup Match on 25 Oct 2015; and
 - (g) Scheduled ground transportation in London.
- 15. The Winners will be drawn at random. UOB reserves the right to draw eligible reserve winners to substitute any Winner subsequently found to be ineligible or disqualified. UOB's determination of the Winners shall be final, conclusive and binding. No correspondence or claims will be entertained.
- 16. All prices and values of the Prize set out in any advertising, promotional, publicity and other materials are purely indicative and for information purposes only and such prices and values may vary in accordance with market fluctuations and other market conditions. UOB accepts no liability for any loss howsoever arising from the use of or reliance on such indicative prices and values.
- 17. The Prize is neither transferable nor exchangeable for cash or otherwise, in full or in part. Any unused portion of the Prize cannot be retained or refunded in cash, credit, other gifts or otherwise in full or in part.

Prize - Notification and Redemption

- 18. The Winners will be notified by ordinary post and telephone based on the contact information in UOB's records within three (3) business days from the determination of the Winners. The results of the Draw will be published in MyPaper (English Section) on 26 August 2015.
- 19. Winners will be required to present proof of identification together with such other additional documents that UOB requires in order to collect the Prize. Further details on how to claim the Prize will be contained in the notification letter.
- 20. The Prize must be claimed by the stipulated date indicated in the notification letterfrom UOB. If the Prize unclaimed by the stipulated date, the Prize will be forfeited (with no liability on the part of UOB to any of the Winners whose Prize was forfeited) and shall be donated to a charity of UOB's choosing. The winner whose Prize has been forfeited is not entitled to any compensation notwithstanding non-receipt of notification for any reason whatsoever.
- 21. UOB may, at any time without notice and without furnishing any reason and in its sole discretion, withdraw or substitute the Prize with other items of similar. UOB's determination of the substituted Prize shall be final, conclusive and binding. No correspondence or claims will be entertained.

By participating in the Draw, the Eligible Cardmember agrees to be bound by the official rules, regulations and decisions of UOB, by the terms contained herein, and by any other applicable terms and conditions. Failure to comply with any applicable terms and conditions will result in a disqualification from the Draw.

The winner(s) consents to UOB using the name, identification/passport number, pictures/photographs of the winner(s) and such other information for print advertisements or other publicity materials; and the winner(s) agree to co-operate with UOB for its publicity purposes without any compensation whatsoever and in such manner as UOB deems fit.
- 25. The Winner shall, if required by UOB, attend any prize presentations and participate in any advertising, promotional and publicity activities relating to or in connection with the Draw at his/her own cost.

General

Further each winner and his/her guest(s) acknowledge that he/she may be required to enter into a direct acknowledgement and/or agreement with RWCL and/or ER2015 concerning use of the tickets and compliance with ticket terms and conditions prior to receiving the prize.

- 28.
