

TERMS AND CONDITIONS FOR UPGRADING A PRINCIPAL CARD VIA SMS

- By applying for an upgrade to your Card (and any related Services) via SMS, you have read understood and agreed to be bound by all the terms in this Agreement. The terms in this Agreement and amendments made to them (at our discretion) from time to time shall apply to any upgraded Card (and related Services) you may apply for and that we may provide you with from time to time.
- 2. The Annual Fee payable for the upgraded Principal UOB PRVI Miles Card is \$\$256.80, which will be waived for the first year only. No Annual Fees are payable for the first two upgraded Supplementary Cards. However, we reserve the right at any time and from time to time in our discretion to vary such terms and impose Annual Fees for any Supplementary Cards.
- 3. Upon our acceptance of your application to upgrade your Card, your Supplementary Card(s) (if any) will also be upgraded. Your current Credit Limit on the Card Account remains unchanged and will be shared between all Cards issued to you, including Supplementary Cardmembers, if any.
- 4. After we have accepted your application to upgrade your Card, you can collect the Card personally, or we can send the Card and its PIN to you (which will be at your own risk) by ordinary post or in any other manner. We are not responsible for the Card or the PIN after it is collected or sent.
- 5. The existing Cards (Principal and Supplementary) will be terminated within 1 month from our acceptance of your application to upgrade your Card ("Termination Date"). All upgraded Cards (Principal and Supplementary) must be activated upon your receipt of the said Cards.
- 6. Only Cardmembers whose Card Account(s) is/are active, valid, subsisting, in good standing and is/are satisfactorily conducted at all times as determined by us in our discretion shall be eligible to apply for an upgrade to the Card.
- 7. All recurring bill payment arrangements to Payee Corporations through your existing Card will not be transferred to your upgraded Card.
- 8. All SMART\$, Krisflyer and Asia Miles accrued on your existing Card up to the Termination Date must be utilized by the Termination Date. All SMART\$, Krisflyer and Asia Miles not utilized by the Termination Date shall be deemed forfeited and shall not be transferred to your upgraded Card.
- 9. The information (whether related to the Cardmembers or Card Account or otherwise) provided by you through this application must match our records for the same subject matter.
- 10. Notwithstanding anything in these terms, we may at our discretion revoke or reject your application to upgrade the Card.
- 11. A person who is not a party to any agreement governed by the Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce or enjoy the benefit of any term of such agreement.
- 12. These terms shall be governed by the laws of the Republic of Singapore and all Cardmembers who apply for any upgrade to a Card (or related Services) shall be deemed to have irrevocably agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
- 13. These terms are supplemental to the prevailing terms and conditions under the UOB Cardmember Agreement ("Standard Terms"). Please visit www.uob.com.sg for the Standard Terms.
