

## **UOB CASHPLUS GRAB THE CASH CONTEST TERMS & CONDITIONS** **("TERMS & CONDITIONS")**

### **1. Eligibility**

1.1 Subject to paragraph 1.2 below, the following are eligible to participate in the UOB CashPlus Contest (the "Contest")

1.1.1 persons who are Citizens or Permanent Residents of Singapore, age 21 – 55, earning a minimum income of \$30,000 per annum and submits a duly completed and signed application form with a copy of NRIC, copy of income document (latest computerized payslip, latest Notice of Assessment or past 6 months' CPF statement); or

1.1.2 persons who have an existing UOB CashPlus Account;

1.2 The following are not eligible for the Contest:

1.2.1 employees of UOB and UOB's subsidiaries and their immediate families;

1.2.2 employees of UOB's partners and advertising and promotions agencies and other persons involved in organizing, promoting and/or conducting the Contest;

1.2.3 persons who are or become insolvent, insane, deceased or have legal proceedings of any nature instituted against them;

1.2.4 persons below the age of 21 years as at 1 January 2005;

1.2.5 estate accounts; and

1.2.6 any other persons as UOB may decide to exclude at its sole and absolute discretion and without notice and without furnishing any reason.

### **2. Qualifying Rounds/Venue**

There will be a total of 6 Qualifying rounds in the month of October.

The top 3 participants who grabs the most cash at each Qualifying round will qualify to play in the Grand Finale on 30<sup>th</sup> October.

**3. Grand Finale/Prize**

- 3.1 The Grand Finale will be held at Hello Singtel on 30<sup>th</sup> October 05 and there will be a total of 18 participants.
  - 3.1.1 All participants get to keep the cash they grab within the designated time period.
  - 3.1.2 The top 2 participants who manage to grab the most cash will play off for the Grand Finale prize of \$10,000.
  - 3.1.3 The Grand Finale winner will get the prize of \$10,000.
  - 3.1.4 The runner up will get two times the cash he/she grabs during the Grand Finale session.
  - 3.1.5 No cash will be given out during the Grand Finale. All prizes will be paid in the form of a cashiers order and to be collected by the participants personally at a date specified by UOB
- 3.2 The results of the Contest will be published in a major daily newspaper within 7 days following the date of the Draw.

**4. Participation / Rules of Play**

- 4.1 UOB shall not be liable in any way to any participants for any injury, loss or damage arising from or in connection with the Contest.
- 4.2 Participants are only allowed to grab the cash with their hands only and not with the assistance of any parts of their body or clothing. For the avoidance of doubt, the use of hands in conjunction with any part of their body will be a violation of the rules.
- 4.3 Cash stuck or attached to any parts of their body or clothing will not be considered as part of the winnings.
- 4.4 Participants who stuffed the cash in any part of their body or clothing will be disqualified.
- 4.5 Participants can only grab cash that is airborne.
- 4.6 Participants will be disqualified if they pick any cash from the floor, sides or any part of the cashbox.
- 4.7 In the event that 2 or more participants accumulate an equal amount of cash during any Qualifying Rounds or the Grand Finale, UOB shall be entitled to select the winner at random or in such other manner as UOB may determine in its sole and absolute discretion.
- 4.8 UOB shall have the right to automatically disqualify any participants in its sole and absolute discretion for non-compliance of any of above rules and all winnings if any shall be forfeited.
- 4.7 Without prejudice to any of the rest of these Terms and Conditions, each participant in the Contest consents to UOB:

- (a) without prejudice to the UOB's rights to disclose information relating to its Customers under common law, the Banking Act (as amended or re-enacted from time to time) or otherwise, disclosing any information relating to such participant or provided by such participant, to any person involved in organizing, promoting and/or conducting the Contest to any regulatory, supervisory or other government authority or body, court of law or tribunal, in Singapore or any other jurisdiction, where such disclosure is required by law, regulation, judgment or order of court or of any tribunal; and
  - (b) using his/her names, personal particulars and photographs for any advertising, promotional and publicity activities relating to or in connection with the Contest and in such manner as the UOB may determine at its sole and absolute discretion.
- 4.8 UOB may at any time at its sole and absolute discretion terminate the Contest or vary any of these Terms and Conditions without prior notice and without furnishing any reason.
- 4.9 Each Winner shall, if required by UOB, attend any prize presentation and participate in any advertising, promotional and publicity activities relating to or in connection with the Contest at his/her own cost and expense.

## **5. General**

- 5.1 In the event of any inconsistency between the Terms and Conditions and any advertising, promotional, publicity and other material relating to or in connection with the Contest, these Terms and Conditions shall prevail.
- 5.2 These Terms and Conditions shall be governed by Singapore laws and the participants of the Contest shall submit to the exclusive jurisdiction of Singapore courts.
- 5.3 A person who is not a party to any agreement governed by these Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any term of such agreement.
