

<u>Terms and Conditions for United Overseas Bank Limited ("UOB") "UOB/CBTL Be the</u> <u>100th UOB Cardmember to Charge to your UOB Card and Win a Free Coffee Machine</u> worth S\$299.00 daily!" CAMPAIGN

- 1. "UOB/CBTL Be the 100th UOB Cardmember to charge to your UOB Card and Win a Free Coffee Machine worth S\$299.00 daily!" (the "Promotion") is open to all eligible UOB cardmembers as herein described.
- 2. Eligibility:
 - (a) "UOB Cards" UOB shall mean Platinum Debit Cards (UOB NOW Debit Card, UOB Direct Debit Card and UOB Debit Visa Card) issued in Singapore and UOB Credit Cards issued in Singapore, excluding UOB PRVI American Express® Card, UOB Preferred Platinum American Express Card, UOB UnionPay Platinum Card, UOB Travel Account Card, Purchasing and Private Label Card unless otherwise stated
 - (b) "Eligible Cardmembers" shall mean all principal and supplementary cardholders of Eligible UOB Card which is valid and subsisting.

All times referred to here and hereinafter are in Singapore time (GMT +8).
- Every day, the 100th Eligible Cardmember who (i) spend between 7.00a.m. and 11.00p.m. at any CBTL store in Singapore; and (ii) makes payment with any of his/her UOB Card shall win one (1) coffee machine worth S\$299.
- 5. Winners of this Promotion will be selected via a computerized system which tracks the number of Eligible Cardmembers paying with UOB Cards and takes into account all Eligible Cardmembers that have made any purchases at any CBTL stores in Singapore.

The winner is required to sign the acknowledgement letter at the CBTL stores and return the original acknowledgement letter to the CBTL stores cashier.
