## UOB NOW DEBIT CARD LAUNCH LUCKY DRAW 2008 TERMS AND CONDITIONS

## 1. Eligibility

- 1.1 Subject to Clause 1.2, the UOB NOW DEBIT CARD LAUNCH LUCKY DRAW (the "Lucky Draw") is open to all eligible cardmembers of UOB NOW DEBIT CARD, whose accounts are valid, subsisting and in good standing as may be determined by United Overseas Bank Limited ("UOB) at its sole and absolute discretion ("Eligible Cardmembers").
- 1.2 The following are not eligible for the Lucky Draw:
  - employees and their immediate families of UOB, Far Eastern Bank Limited and its subsidiaries;
  - employees of advertising and promotion agencies engaged by UOB and any other persons involved in organizing, promoting and/or conducting the Lucky Draw;
  - c. Principal Cardmembers whose accounts are terminated between 28 April 2008 and the Draw Date (both dates inclusive);
  - d. persons who are or become insane, deceased, insolvent or have legal proceedings of any nature instituted against them; and
  - e. any other person as UOB may decide to exclude at its sole and absolute discretion and without notice and without furnishing any reason.

## 2. Qualifying Period

2.1 "Qualifying Period" for the Lucky Draw means the period 28 April 2008 to 31 July 2008 (both dates inclusive).

#### 3. Draw Date

3.1 The Lucky Draw will be conducted on 5 September 2008 in the presence of UOB's internal auditors, or on such other dates as UOB may decide at its sole and absolute discretion ("the Draw Date").

## 4. Allocation of Lucky Draw Chances

- 4.4 The transaction records of UOB and the total number of Lucky Draw chances allocated to an Eligible Cardmember shall be final and conclusive.
- 4.5 Annual fee charges, interest charges, late payment charges, finance charges, cash advance,

balance transfers and other miscellaneous fees and charges will not be taken into account for
