**Terms and Conditions governing UOB Credit Cards DELSEY Luggage Special Buy Promotion (16 September – 31 October 2016) (“Promotion”)**

1.
  - (i) This Promotion is only applicable to selected principal credit cardmembers of a UOB Credit Card(s) who has received either a SMS and/or billing insert from United Overseas Bank Limited (“UOB”) regarding this Promotion (“**Cardmember**”). The term “*UOB Credit Card(s)*” refers to any Visa, MasterCard, American Express, UnionPay and JCB credit card issued by UOB in Singapore with the exception of any UOB Travel Account, Corporate (on corporate liability), Purchasing, Business, Multicurrency Corporate and Private Label cards.
  - (ii) Without limiting the generality of this Paragraph 1, the following Cardmembers shall not be eligible for this Promotion:
    - (a) Cardmembers whose UOB Credit Card(s) account(s) is/are voluntarily or involuntarily suspended, cancelled or terminated during the Promotion Period and for the avoidance of doubt, termination of a supplementary Cardmembers UOB Credit Card(s) account(s) will not by itself disqualify the principal Cardmember from this Promotion;
