If, for any reason whatsoever (for example, any part of the New Deposit Amount has been withdrawn) UOB is unable to earmark any New Deposit Amount I shall be deemed to have withdrawn from the Promotion and shall not be entitled to receive any Travel Voucher(s), in respect of that New Deposit Amount.
4. I understand that the Withheld New Deposit Amount may not be drawn upon the Minimum Period without first withdrawing my participation in the Promotion.
5. I acknowledge that I will need to maintain sufficient funds in the account in excess of the Withdrawal New Deposit Amount for financial commitments and that if cheques / GIROs etc, are returned or rejected due to there being insufficient funds in the account in excess of the Withheld New Deposit Amount, I will be liable for the associated charges.

If I decide to withdraw my participation in the Promotion before the expiry of the Minimum Period for any reason, I agree to give (1) Business Day advance notice for the release of earmark on the relevant New Deposit Amount(s) by completing and submitting to UOB the required "Family and Friends Deposit Promotion – Withdrawal of Participation Form". I authorize UOB to debit my UOB FlexiDeposit / i-Account for a sum equivalent to the full value of the Travel Voucher(s) given as UOB determines, in its sole and absolute discretion, to be relevant for the New Deposit Amount(s) in respect of which the earmark is released (the "Withdrawn New Deposit Amount").
