

<u>UOB FLEXIDEPOSIT FESTIVE PROMOTION NOV/DEC 2004</u> TERMS AND CONDITIONS

1. ELIGIBILITY

- a. This Promotion is open to customers who open a new UOB FlexiDeposit account with a minimum deposit of \$\$50,000.
- b. Customer(s) who open a new FlexiDeposit account with a minimum deposit of \$\$50,000 outside the promotional period is not eligible for the gifts/rewards.

2. PROMOTIONAL PERIOD

a. The promotional period begins from 22 November to 31 December 2004.

3. OFFER

The following rewards/gifts are offered to customers who open a **new UOB FlexiDeposit account** during the promotional period:

Deposit Amount	Gift
S\$50,000 - S\$99,999	S\$30 gift voucher from Isetan
S\$100,000 - S\$199,999	One (1) air-ticket to Hatyai (return)
\$\$200,000 and above	Two (2) air-tickets to Bangkok (return)

- a. Gifts offered for the UOB FlexiDeposit Festive Promotion is non-negotiable and non-exchangeable for cash or in kind.
- b. Deposits must be made in fresh funds i.e. funds not transferred from any existing UOB Savings or Current Account.
- c. Deposits shall remain in the account for a minimum of 3 months. In the event the customer withdraws his/her deposits (all or part thereof), PFS Deposits has the sole discretion to allocate the appropriate gift to the customer or request the customer to refund the entire cost of the gift.

5. ISSUANCE OF REDEMPTION LETTERS

- e. The Redemption Letter from UOB is not replaceable. No claims will be entertained if the Redemption Letter is lost, torn, defaced or damaged.

6. TERMS AND CONDITIONS OF GIFTS/REWARDS

a. Isetan Voucher

i. The value of the Isetan voucher is \$\$30.

- ii. The redemption letter for the Isetan voucher is valid for one (1) month upon the date of the redemption letter issuance. Once the customer redeem the Isetan voucher, the vouchers are valid for one (1) year from the date of redemption.
- iii. The Isetan voucher cannot be exchanged for cash, in kind or used to settle outstanding credit balances.
