

**Shop for FREE via UOB 0% Instalment Plan at Best Denki Lucky Draw**  
**Terms and Conditions**

**1. Eligibility**

- 1.1 The United Overseas Bank ("UOB") Shop for FREE via UOB 0% Instalment Plan at Best Denki Lucky Draw ("the Draw") is opened to all eligible UOB Credit Card customers as herein described:
- 1.2 Subject to the provisions herein and in particular, Rule 1.3, "Eligible Customers" shall mean all UOB Credit Card accounts of UOB (collectively referred to as "Accounts") which are valid, subsisting and in the opinion of UOB in good standing.
- 1.3 Notwithstanding anything herein, UOB has the absolute discretion at any time and from time to time to determine the eligibility of any customers and shall not be obliged to give any reason therefore. Without limiting the generality of this provision, Eligible Customers:
- i. who are staffs or Directors of United Overseas Bank Ltd and Best Denki Singapore Ptd Ltd during the Period (as hereinafter defined);
  - ii. whose principal Account(s) is/are terminated between 1 April 2008 and the Draw Date (both dates inclusive);
  - iii. who are deceased or who face legal incapacity;
  - iv. who face legal proceedings or any threat of legal proceedings;
  - v. whose accounts are otherwise determined by UOB in its absolute discretion as being delinquent or unsatisfactorily conducted for any reason;

at any time before the Draw Date shall be disqualified and shall not be entitled to any payment or compensation whatsoever, even if he or she has been selected to be the winner of the Draw.

This promotion is not applicable to UOB JCB card, ONE Card MasterCard, Bank 121 Card, Travel Accounts, Purchasing and Private Label card.

**2. Dates**

The Qualifying Period for this Promotion commences on 1 April and ends on 30 June 2008 (both dates inclusive).

**3. Allocation of Chances**

- 3.1 1 Lucky Draw chance will be awarded for a charge amount of S\$1,500 and above to a UOB Credit Card via UOB 0% Instalment Payment Plan at any of the 9 Best Denki outlets during the qualifying period.
- 3.2 Cardmembers must complete the Lucky Draw Form, attach together with their UOB charge slip and drop it into UOB Lucky Draw Box located at the Customer Service Counters in all Best Denki outlets within the qualifying period to qualify for the Draw.
- 3.3 Lucky Draw Forms that are incomplete and/or without attached UOB charge slip will be deemed as disqualified.
- 3.4 The total number of chances allocated to an Eligible Customer shall be final and conclusive.

#### **4. Draw Dates**

- 4.1 Unless UOB notifies otherwise, the Draw for the winners will be conducted on 8 July 2008 or other dates as UOB may determine at their sole and absolute discretion ("the Draw Date"), in the presence of the internal auditors of UOB at United Overseas Bank, 480 Toa Payoh Lorong 6, #25-01 HDB Hub East Wing (S) 310480.
- 4.2 UOB reserves the right to draw reserve winners to substitute any winner subsequently found to be disqualified. UOB's determination of the winners shall be final, conclusive and binding. No correspondence or claims will be entertained.

#### **5. Prizes**

- 5.1 There shall be a total of 9 winners (1 from each Best Denki outlets) for the Draw. Each winner will be entitled to win S\$3,000 worth of Best Denki Vouchers each.
- 5.2 The prize is not transferable for cash or otherwise. UOB shall not be responsible for any consequences including but not limited to loss of life, injury to person and/or damage to property arising from or in connection with the Draw and/or redemption or use of the prize.
- 5.3 The winners' names and NRIC Nos will be published on The Straits Times within one month from the date of the draw.
- 5.4 The winners will be notified by post within 14 days of the draw based on the information provided on the Lucky Draw Form.

- 6.3 These Terms and Conditions shall be governed by the laws of Singapore, and all Eligible Cardmembers who participate in the Draw shall be deemed to have agreed to submit to the exclusive jurisdiction of the Singapore Courts.
