

SHIFT TO DOUBLE SMART\$ EVERY SUNDAY PROMOTION TERMS AND CONDITIONS

1 <u>Eligibility</u>

- 1.1 Subject to Clause 1.2, SHIFT TO DOUBLE SMART\$ EVERY SUNDAY PROMOTION ("the Promotion") is open to all eligible UOB credit cardmembers and UOB NOW/DIRECT Debit Cards which are valid, subsisting and in good standing as may be determined by United Overseas Bank Limited ("UOB") at its sole and absolute discretion (collectively "Eligible Cardmembers" or each an "Eligible Cardmember").
- 1.2 The following are not eligible for the Promotion:
 - 1.2.1 Cardmembers whose accounts are terminated between 30 May 2010 and 15 August 2010 (both dates inclusive);
 - 1.2.2 Persons who are or become insane, deceased, insolvent or have legal proceedings of any nature instituted against them;
 - 1.2.3 Any accounts that are deemed to be delinquent or unsatisfactorily as determined by UOB at its sole and absolute discretion; and
 - 1.2.4 Any other persons as UOB may decide to exclude at its sole and absolute discretion without notice and without furnishing any reason.
- 1.3 This Promotion is not extended to (a) credit cardmembers of UOB CUP Card, Bank 121 Card and Private Label Card; (b) UOB customers of Travel Accounts, Purchasing Card; and (c) all purchases made at Shell Autoserv.

2. The Promotion

- 2.1 The Promotion entitles Eligible Cardmembers to double SMART\$ at Shell petrol stations. (Appendix 1)
- 3 Promotion Period
- 3.1 The Promotion commences on 30 May 2010 and ends on 29 August 2010, both

dates inclusive (the "Promotion Period").

4. Participating Merchant

4.1 The participating merchant of the Promotion in Singapore is Shell Eastern Petroleum Pte Ltd.

5. General

- 5.1 SMART\$ is non-transferable and cannot be exchanged for cash.
- 5.2 The decisions of UOB on all matters relating to the Promotion are final, conclusive and binding. UOB shall not be obliged to give any reason or enter into any correspondence with any persons on any matter concerning the Promotion.
- 5.3 Notwithstanding anything in these Terms and Conditions, UOB reserves the right at any time in its absolute discretion to determine and/or amend, by addition to, subtraction from or variation of, these Terms and Conditions without prior notification, including but not limited to the eligibility terms and criteria, the selection of the Eligible Cardmembers and the Cardmember's designated UOB Card for the Promotion, and the timing of any act to be done, and all participants shall be bound by these amendments.
- 5.4 In the event of any inconsistency between these Terms and Conditions and any advertising, promotional, publicity and other materials relating to or in connection with the Promotion, these Terms and Conditions shall prevail.
- 5.5 A person who is not a party to these Terms and Conditions has no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any term herein..
- 5.6 These Terms and Conditions shall be governed by the laws of Singapore, and all Eligible Cardmembers who participate in the Promotion shall be deemed to have agreed to submit to the exclusive jurisdiction of the Singapore Courts.
