Complimentary 1-day DataRoam Saver (Daily) Plan Terms and Conditions

- a. UOB will procure SingTel (the "Service Provider") to supply the complimentary 1-day DataRoam Saver (Daily) Plan (the "Service").
- b. This Service is only available for Principal Cardmembers. Principal Cardmembers must register online at <u>www.uob.com.sg/SingTelDataRoam</u> and charge prior travel-related transactions (limited to air ticket bookings, hotel bookings or any travel package from a travel or tour agency) of a minimum amount of S\$500 to their SingTel-UOB Cards to qualify for the Service. The qualifying travel-related transactions must be charged from 1 May 2013 to 31 May 2013 and a minimum 3-day DataRoam Saver (Daily) plan sign up is required.
