

SHELL Q2'11 PROMOTION - \$8 off | Shell Fuels + Treats!

TERMS AND CONDITIONS

- 1. From 11 April to 22 May 2011 ("Promotion Period"), with every \$\$50.00 purchase of any Shell fuels (before any applicable station, card discount or rebate) in a single receipt at Shell stations in Singapore, customers will receive a sticker ("Sticker"), upon presenting this card ("Card"). If the purchase is in multiples of \$\$50.00, a Sticker will be given for every \$\$50.00.
- 2. Customers can collect the Stickers on the cards and present them for a treat ("Treat"). The type and value of the Treat shall be determined by Shell and may change from time to time without notice to the Customer. A Treat will be given for every S\$50.00. In addition, when Customers next purchase a minimum of gross \$50.00 of fuels at any Shell station, they may present a completed Card (i.e. with 3 Stickers) to the cashier before making payment to receive \$8.00 off. Only one completed card may be used for each fuel purchase.
- 3. Completed Cards may be presented to get \$8 off the next fuel purchase until 5 June 2011. However, the \$8 off promotion cannot be used in conjunction with other offers, discounts, discount vouchers, privileges or promotions unless otherwise stated. No extensions will be permitted.
- 4. Stickers or Treats will not be issued during the "Shell V-Power at the price of Shell FuelSave 98" promotion. The \$8.00 off promotion is not valid during any "Shell V-Power at the price of Shell FuelSave 98" promotion.
- Customers may only collect Stickers and redeem Treats during the Promotion Period. Shell will not under any circumstances, extend the expiry date of any incomplete Card or extend the date for redemption.
- 6. Individual Cards with less than 3 Stickers each will be considered incomplete and cannot be combined for redemption.
- 7. Treats are distributed only while stocks last. During the Promotion Period, stocks of Stickers, Treats or Cards may run out at particular stations. Shell shall bear no liability to the customer in such a case.
- 8. Treats are subject to their respective terms and conditions and those stated herein.
- 9. Stickers, Treats and/or Cards are NOT exchangeable either wholly or partially, for cash or for other goods and services.
- 10. Only original Cards and Stickers will be accepted. The completed Card is valid for one time use and will be retained by Shell Eastern Petroleum (Pte.) Ltd ("Shell") upon redemption.
- 11. This promotion does not apply to Corporate Shell Card purchases and Shell Preferred Partners Program.
- 12. Incomplete or failure to provide true and accurate information, failure to submit original receipts upon collection of the Treat will automatically disqualify the participant from the promotion. Even if the completed card is presented, Shell shall have the sole discretion to determine whether any participant should be disqualified by reason of failure to abide by these terms and conditions, bad faith, fraud or any other legitimate reason.
