UOB CASHPLUS FUNDS TRANSFER PROMOTION TERMS & CONDITIONS

Please read these Terms and Conditions carefully. A UOB CashPlus account holder ("Applicant") may, subject to the Terms and Conditions herein, apply to transfer the outstanding balance ("Funds Transfer") on his/her bank/credit card/credit line account(s) held with any bank in Singapore, other than United Overseas Bank Limited (the "Bank") to the Applicant's UOB CashPlus Account (the "Account") under the UOB CashPlus Funds Transfer promotion

- The Funds Transfer promotion ("Funds Transfer Promotion") is open to any Applicant whose Account is in good standing as determined by the Bank.
- The Funds Transfer amount shall not be less than S\$500 for each Funds Transfer and shall not exceed 90% of the Applicant's available credit limit at the time of the application ("Approved Amount").
- Funds transfer from your UOB CashPlus account to any UOB account with an overdraft facility is not permitted.

- Any approved funds transfer amount shall first be drawn from any credit balances available in your UOB CashPlus account at point of debit. The promotional interest rate is only applicable on the utilised limit of your CashPlus account.
- The Promotional Interest Rate is valid for the duration of the Promotional Tenor with effect from the date the Bank approves the Funds Transfer request ("Promotion Period") and the Bank's prevailing interest rate shall apply to all amount utilised in excess of the Approved Amount during the Promotional Period.
