UOB Gold or Classic Card S\$30 Voucher Campaign 2013

Terms and Conditions

1. **ELIGIBILITY**

- 1.1 To be eligible for United Overseas Bank Limited's ("UOB") "Gold or Classic Card S\$30 Voucher Campaign" (the "Promotion"), the Eligible Cardmember must have, during the Qualifying Period (as defined under Paragraph 2 below), successfully meet the Qualifying Spend requirement. - (b) whose Eligible Card account(s) is/are not active, valid, subsisting or in good standing or which are otherwise determined by UOB as being delinquent or unsatisfactorily conducted for any reasons as may be determined by UOB at its discretion;
- (c) those who are mentally unsound, facing legal incapacity or is incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or
- (d) who UOB may decide to exclude, at its discretion, without prior notice at any time during the Qualifying Period.

2. QUALIFYING PERIOD

The Promotion is valid only for Qualifying Spend requirement made and captured posted between 12.00 a.m. on 1 May 2013 to 11.59 p.m. on 30 June 2013 (Singapore date/time), both dates and times inclusive ("Qualifying Period") subject to all the terms and conditions herein.
