

## TOKYO DISNEYLAND HOLIDAY LUCKY DRAW

### TERMS AND CONDITIONS

# 1. Eligibility

1.1 Subject to Clause 1.2, the Tokyo Disneyland Holiday Lucky Draw ("the Lucky Draw") is open to all eligible principal holders of UOB JCB Platinum Card ("Cardmember") which are valid, subsisting and in good standing as may be determined by United Overseas Bank Limited ("UOB") at its sole and absolute discretion (collectively "Eligible Cardmembers or each an "Eligible Cardmember").

For avoidance of doubt, (a) the benefit of all charges incurred by a supplementary Cardmember in respect of Lucky Draw shall accrue to the Eligible Cardmember; (b) termination of a supplementary Cardmember's account will not by itself disqualify the Eligible Cardmembers from the Lucky Draw.

- 1.2 The following are not eligible for the Lucky Draw:
  - 1.2.1 Directors and employees of UOB
  - 1.2.2 Employees of UOB's partners, advertising and promotion agencies and any other persons involved in organizing, promoting and/or conducting the Lucky Draw;
  - 1.2.3 Principal Cardmembers whose accounts are terminated between 28 August 2009 and the relevant Draw Date (both dates inclusive);
  - 1.2.4 All Corporate Cards, Purchasing Cards and Travel Accounts;
  - 1.2.5 Persons who are of unsound mind, deceased, insolvent or have legal proceedings of any nature instituted against them;
  - 1.2.6 Persons below the age of 21 years as at the relevant Draw Date; and
  - 1.2.7 Any other accounts that are deemed to be delinquent or unsatisfactorily conducted by UOB at its sole and absolute discretion.

# 2. Qualifying Period

2.1 "Qualifying Period" for the Lucky Draw means the period commencing 28 August 2009 to 31 December 2009 (both dates inclusive).

## 3. Allocation of Lucky Draw Chances

- 3.1 One (1) Lucky Draw chance will be allocated to every Eligible Cardmember for every S\$30 retail spend during the Qualifying Period. Retail spend excludes annual fees, reversals and finance charges.
- 3.2 In addition to the Lucky Draw chances earned the during the Qualifying Period, ten (10) Lucky Draw chances will be allocated for each successful UOB JCB Platinum Card application between 28 August 2009 and 31 October 2009 (both dates inclusive)
- 3.3 All transactions made during the Qualifying Period must be posted and captured by UOB's Loyalty system in order to qualify for the Lucky Draw.
- 3.4 UOB shall not be responsible for any failure or delay in the transmission of evidence of sales transactions by JCB Acquiring Merchants, merchant establishments, postal or telecommunication authorities or any other party which may result in a charge incurred or cash advance made by the Eligible Cardmember and/or his/her supplementary Credit Cardmember(s) as being omitted from the allocation of Lucky Draw chances by UOB during the Qualifying Period.
- 3.5 UOB's transaction records and the total number of Lucky Draw chances allocated to an Eligible Cardmember shall be final and conclusive. No correspondence will be entertained.

#### 4. Draw Dates

- 4.1 The Lucky Draw will be conducted on 22 January 2010 or such other dates as UOB may determine at its sole discretion at United Overseas Bank, 480 Toa Payoh Lorong 6, #25-01, HDB Hub East Wing, Singapore 310480 or at such other venue as may be determined by UOB.
- 4.2 UOB reserves the right to draw reserve winners to substitute any winner subsequently found to be disqualified. UOB's determination of the winners shall be final, conclusive and binding. No correspondence or claims will be entertained.

## 5. Prize

- 5.1 The prize of two (2) Japan Airlines Economy Class return air-tickets to Tokyo, two (2) nights' stay at Grand Prince Hotel New Takanawa and two (2) adult passes to Tokyo Disneyland will be given away to one (1) winner at the Lucky Draw.
- 5.2 The two Japan Airlines Economy Class return air-tickets to Tokyo are valid for travel till 30 Jun 2010 and are exclusive of any airport taxes and fuel surcharges.
- 5.3 The two nights' stay at Grand Prince Hotel New Takanawa excludes any peak surcharges and any other changes where applicable.
- 5.4 The prize is neither transferable nor exchangeable for cash or otherwise. UOB shall not be responsible for any other consequences including but not limited to

- loss of life, injury to person and/or damage to property arising from or in connection with the Lucky Draw and/or redemption or use of the prize.
- 5.5 UOB may, at any time without notice in its sole and absolute discretion, substitute any prize with another prize of similar value.
- 5.6 The winner will be notified by post and/or contacted via telephone based on the last known contact information in UOB Card Centre's records.
- 5.7 All prizes must be claimed in Singapore on or before 31 March 2010. All unclaimed prizes will be forfeited. Any winner whose prize has been forfeited shall not be entitled to any payment or compensation notwithstanding non-receipt of notification.

# 6. Participation

- 6.1 It is a condition precedent for participation in the Lucky Draw that the winner consents to the public disclosure of his/her name, identification/passport number and such other information that may indicate his/her accounts with UOB and photographs for publicity or commercial purposes or otherwise participate in the publicity activities of UOB in relation to the Lucky Draw and to the use of any date provided by such winner for any future marketing effort by the UOB group of companies, without any payment or compensation thereof.
- 6.2 The winner shall, if required by UOB attend any prize presentation and participate in any advertising, promotional and publicity activities relating to or in connection with the Lucky Draw at his/her own costs.

### 7. General

- 7.1 The decisions of UOB on all matters relating to the Lucky Draw are final, conclusive and binding. UOB shall not be obliged to give any reason or enter into any correspondence with any persons on any matter concerning the Lucky Draw.
- 7.2 Notwithstanding anything in these Terms and Conditions, UOB reserves the right at any time in its absolute discretion to determine and/or amend, by addition to, subtraction from or variation of, these Terms and Conditions, without prior notification, including but not limited to the eligibility terms and criteria, the selection of winners, and the timing of any act to be done, and all participants shall be bound by these amendments.
- 7.3 In the event of any inconsistency between these Terms and Conditions and any advertising, promotional, publicity and other materials relating to or in connection with the Lucky Draw, these Terms and Conditions shall prevail.
- 7.4 A person who is not party to any agreement governed by these Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any term of such agreement.
- 7.5 These Terms and Conditions shall be governed by the Laws of Singapore, and all Eligible Cardmembers who participate in the Lucky Draw shall be deemed to have agreed to submit to the exclusive jurisdiction of the Singapore Courts.
- 7.6 Except where it otherwise requires, words denoting the singular include the plural and vice versa.
