

# Terms & Conditions Governing Insure &Travel <sup>Enhanced</sup> Promotion (1 September 2014 to 5 October 2014) ("Promotion")

## 1. Introduction

- 1.1 The Promotion is jointly organised by United Overseas Bank Limited ("UOB") and United Overseas Insurance Limited ("UOI"), collectively known as Organiser.
- 1.2 The Promotion shall commence from 1 September 2014 to 5 October 2014 (both dates inclusive) ("Promotion Period").
- 1.3 Each relevant "Promotional Week" in the Promotional Period is set out below:

Any incomplete or inaccurate Forms will be disqualified for the Promotion.

- 2.2 In each Promotional Week, ten (10) participants ("Weekly Winners") with the highest score and the fastest time in the Game will enter into the Hall of Fame and will receive the Gift. In the event of a tie between the participants with the same score and time, the first in time to enter into the Hall of Fame will be awarded the Gift.

- 2.4 The Weekly Winners will be notified through email at the address indicated in their Forms.
- 2.5 Each participant is only eligible to receive a maximum of one (1) Gift during the Promotion Period, irrespective of the number of times the participant appears on the Hall of Fame during the Promotion Period.

- 2.7 The Gift is not exchangeable for cash, in full or in part. The value of the Gift for each Promotional Week may vary. The Organiser reserves the right to replace and/or substitute any of the Gifts under this Promotion with another gift of similar value without giving prior notice or reason to the Weekly Winners.

#### 3. Grand Draw

- 3.1 A Grand Draw will be conducted at 80 Raffles Place, #38-01 UOB Plaza 1, Singapore 048624 on 20 October 2014 at a time to be determined by the Organiser or on such other date or time or at such other venue as may be determined by the Organiser at its sole discretion.
- 3.2 The Grand Draw will determine one winner for each Promotional Week. Eligible participants will stand a chance to win:
  - (a) A pair of Singapore Airlines air ticket to a designated country which will be revealed by the Organiser at the start of the relevant Promotional Week; and

- 3.8 The results of the Grand Draw will be announced and published on uob.com.sg/savvy and in TODAY on 22 October 2014. Winners of the Grand Draw will be notified by ordinary post sent to the address indicated in the Form. The posting and/or publication of the results of the Grand Draw shall be conclusive proof of notification to the winner(s).



- 3.9 Each participant is only eligible to win a maximum of one (1) Prize during the Promotion Period.
- 3.10 All Prizes must be collected in person or by an authorised representative within thirty (30) days from the date of the notification letter. At point of collection, the authorised representative must present (i) the original notification letter; (ii) an authorisation letter from the winner; (iii) a copy of the identification card or passport of the winner; and (iv) the original identification card or passport of the authorised representative.
