

## Terms and Conditions Governing the United Overseas Bank Limited Insure & Travel Promotion (10 March 2014 to 31 March 2014) ("Promotion")

### 1. Promotion

- 1.1. This Promotion is valid from 10 March 2014 to 31 March 2014 (both dates inclusive) ("Promotion Period") and is applicable to new purchases of Insure & Travel Per Trip Plans and Insure & Travel Annual Plans ("Plans") underwritten by United Overseas Insurance Limited ("UOI") and distributed by United Overseas Bank Limited ("UOB").
- 1.2. During the Promotion Period, each new purchase shall be entitled to a 25% discount on Insure & Travel Per Trip Plans and 10% discount on Insure & Travel Annual Plans.
- 1.3. This Promotion applies to new application(s) submitted during the Promotion Period only. Existing policyholders of the Plans purchased prior to 10 March 2014 who wish to renew or amend the coverage of their existing Insure & Travel Annual Plans are not eligible for this Promotion.

### 2. Exclusive for purchases made through our 24-hour Hotline

- 2.1. 5% SMART\$ will be awarded for each successful transaction charged to a UOB MasterCard/ Visa credit card or debit card, purchased via the 24-hour UOI hotline.
- 2.2. UOB SMART\$ Rebates Programme is only applicable for UOB debit cards and credit cards issued in Singapore which are valid and subsisting. It is not applicable to UOB Preferred Platinum American Express Cards, UOB UnionPay Platinum Cards, UOB Travel Account Cards, Purchasing and Private Label Card unless otherwise stated.
