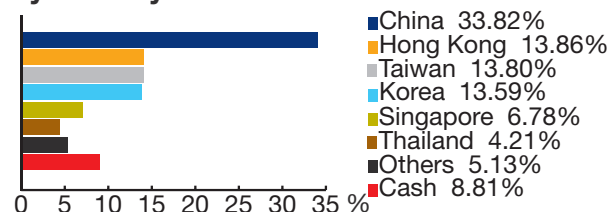
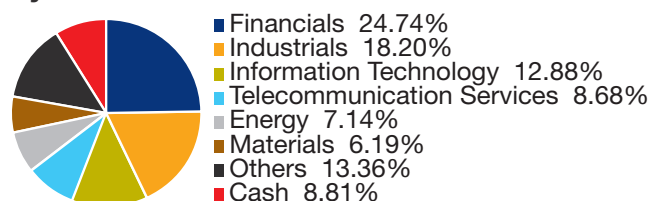


**Fund Objective**

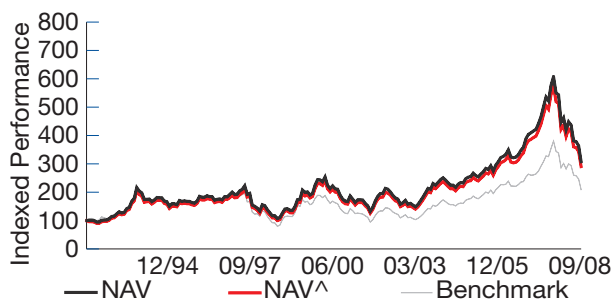
