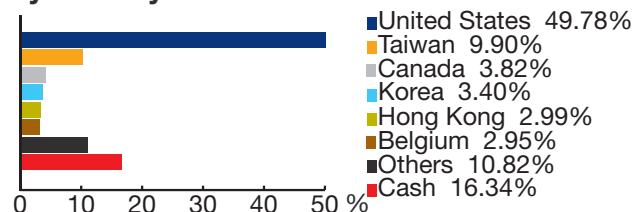
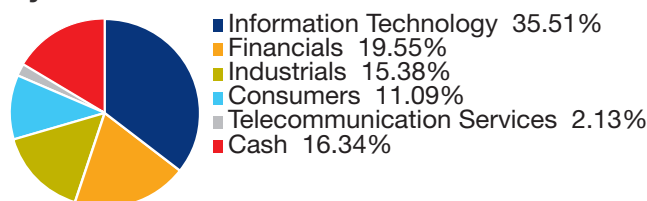


Fund Objective

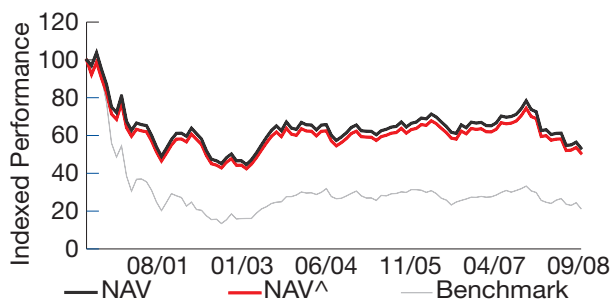
