

UOB VISA Sydney Dream Holiday Lucky Draw 2006 TERMS AND CONDITIONS

Eligibility

- 1.1 The UOB Overseas Bank Limited ("UOB") VISA SYDNEY Dream Holiday Lucky Draw ("the Draw") is open to all eligible UOB VISA Credit Cardmembers as herein described.
- 1.2 Subject to the provisions herein and in particular, Rule 1.3, "Eligible Cardmembers" shall mean all principal UOB VISA Credit Cardmembers accounts of UOB (collectively referred to as "Cards" and each a "Card") which are valid, subsisting and in the opinion of UOB in good standing.
 - For the avoidance of doubt, the benefit of all charges incurred by a supplementary Cardmember in respect of this Draw shall accrue to the Eligible Cardmember.
- 1.3 Notwithstanding anything herein, UOB has the absolute discretion at any time and from time to time to determine the eligibility of any Credit Cardmember and shall not be obliged to give any reason therefore. Without limiting the generality of this provision, Eligible Cardmembers:
 - who are a staff or Director of United Overseas Bank Ltd and Far Eastern Bank Ltd during the Period (as hereinafter defined), Saatchi & Saatchi Singapore (only staff who are handling the UOB account), advertising agencies which handle this Draw or who have an interest in this Draw;
 - ii. whose principal Card Account(s) is/are terminated between 6 October 2006 and the Draw Date (both dates inclusive);
 - iii. who are deceased or who face legal incapacity:
 - iv. who face legal proceedings or any threat of legal proceedings;
 - v. whose accounts are otherwise determined by UOB in its absolute discretion as being delinquent or unsatisfactorily conducted for any reason;

at any time before the Draw Dates shall be disqualified and shall not be entitled to any payment or compensation whatsoever, even if he or she has been selected to be the winner of the Draw. For the avoidance of doubt, termination of a supplementary Credit Cardmember's account will not by itself disqualify the Eligible Principal Cardmember from the Draws.



2. Allocation of Chances

- 2.1 Ten chances are allocated for new UOB Visa applicants with cards successfully issued from 6 October to 25 December 06.
 - One chance will be allocated for every Eligible Cardmember with every \$30 charged during the qualifying period on their UOB VISA Credit Card.
- 2.2 UOB shall not be responsible for any failure or delay in the transmission of evidence of sales transactions by MasterCard/Visa Acquiring Merchants, merchant establishments, VISA International Incorporated, postal or telecommunication authorities or any other party(s) which may result in a charge incurred or cash advance made by the Eligible Credit Cardmember and/or his supplementary Credit Cardmember(s) as being omitted from the allocation of chances by UOB during the Period.
- 2.3 The records of transactions of UOB and the total number of chances allocated to an Eligible Credit Cardmember shall be final and conclusive.

3. Draw Dates

- 3.1 Unless UOB notifies otherwise, the Draw will be conducted on 8 January 2007 or such other dates as UOB may determine at their sole and absolute discretion ("the Draw Date"), in the presence of the external auditors of UOB at Singapore Press Holding, 82 Genting Lane, Level 7 (S)349567.
- 3.2 UOB reserves the right to draw reserve winners to substitute any winner subsequently found to be disqualified. UOB's determination of the winners shall be final, conclusive and binding. No correspondence or claims will be entertained.

4. Prizes

- 5.3 These Terms and Conditions shall be governed by the laws of Singapore, and all Eligible Cardmembers who participate in the Draw shall be deemed to have agreed to submit to the exclusive jurisdiction of the Singapore Courts.
