

Terms and Conditions Introduce A Friend Programme (1 July 2015 to 31 December 2015)

• The UOB Property Loans – Introduce A Friend Programme ("Programme") is extended to all existing customers of United Overseas Bank Limited ("**UOB**") who has at least one banking product under his/her personal name with UOB ("**Introducers**"). This Programme is not applicable to staff of UOB Group.

• An Introducer is entitled to receive only one (1) reward (as described below) per Referred Customer (as defined below) if during the period commencing from 1 July 2015 till 31 December 2015:-

- (1) the Introducer refers a Referred Customer to UOB:-
 - (a) in connection with any of the following referrals:-
 - referrals for HDB and Private Residential Property Home Loans, Commercial Property Loans, Term Loans against unencumbered Private Residential properties or Commercial properties, Australia, London, Malaysia, Thailand and Japan Property Loans financed in Singapore; or

 - (iii) S\$400,000.00^ for Australia, London and Japan Property Loans.
 - ^ or its equivalent amount if the loan is approved in other currencies

AND

(2) UOB's letter of offer in connection with that referral is accepted by the Referred Customer by 31 December 2015.

If more than one Introducer successfully refers the same Referred Customer to UOB, UOB shall have the discretion regarding the recipient of the reward.

For the purposes of the Programme, the term "*Referred Customer*" refers to an individual who does not have any existing property loan with UOB and who is not represented by a property agent.

• Introducers cannot refer themselves to receive the rewards under this Programme.

• UOB Group refers to any of UOB's branches, representative offices, affiliated, associated or related corporations whether in Singapore or elsewhere.

• UOB reserves the right not to contact the Referred Customer for any reason whatsoever and UOB shall not be liable for any compensation to the Introducer if (1) UOB exercises its right not to contact the Referred Customer or (2) the Referred Customer is not eligible for any property loan under this Programme or whatsoever, thereby resulting in the Introducer not being eligible for the reward offered under this Programme.
