#### MARINA BAY SANDS - UNITED OVERSEAS BANK LIMITED ASIA'S DINING DESTINATION MONTHLY AND GRAND LUCKY DRAW TERMS AND CONDITIONS

The Marina Bay Sands - United Overseas Bank Limited Asia's Dining Destination Monthly and Grand Lucky Draw is subject to the terms and conditions set out below.

# 1. MEANING OF WORDS

Applicable Card means the Card which the winning transaction was charged to.

Card means any credit card or debit card issued by UOB in Singapore

Draw Date means the date the Monthly Draw is conducted.

**Eligible Cardmember** means, existing and new principal account holders of any credit card and/or debit card issued by UOB in Singapore and whose credit card and debit card accounts are valid, subsisting and in UOB's opinion, in good standing.

**Lucky Draw** means this Marina Bay Sands - United Overseas Bank Limited Asia's Dining Destination Monthly and Grand Lucky Draw.

- b) Each Monthly Draw will be conducted in the presence of the external auditors of UOB at Singapore Press Holdings Limited, 1000 Toa Payoh North, News Centre, Singapore 318994 or at such other location determined by UOB.
- c) Details of the Monthly Draw winners (such as full name and NRIC number) will be published in local newspaper(s) on a Sunday in the month immediately following the Draw Date. The winner of each Monthly Draw will also be notified by post and/or by telephone call based on the last known contact details in UOB card centre's records.

## 4. QUALIFYING CRITERIA - GRAND DRAW

- a) By charging a minimum amount of S\$50-00 in a single receipt to the Eligible Cardmember's Card at a minimum of ten (10) different Participating Outlet during the Qualifying Period, the Eligible Cardmember:-

- (ii) Five (5) nights hotel stay at the selected destination above ("hotel stay").
- b) If the entire bill for the dinner exceeds S\$1,000-00, the difference shall be borne by the winner of the Grand Draw.
- c) (i) The winner must collect the travel voucher for the flights and hotel stay from UOB (at 480 Toa Payoh Lorong 6 #25-01 HDB Hub East Wing Singapore 310480) within one (1) month from the date of the Notification. - e) UOB shall not be responsible for the quality, merchantability or fitness for any purpose or any other aspect of any of the prizes given in connection with this Lucky Draw. UOB assumes no liability or responsibility for the acts or defaults of the merchants or defects in the goods and services offered in connection with this Lucky Draw.
