Terms and Conditions Governing United Overseas Bank Limited ("UOB") "Siloso Beach Party Contest"

- 2. To be eligible for the Contest, each participant must be a fan of UOB Facebook Page and a UOB credit/debit cardmember (the "Participant").
- 3. Only entries submitted online via UOB Facebook Page during the Contest Period are qualified for the Contest. For the avoidance of doubt, UOB shall not be responsible for any entry that fails to reach us before the expiry of the Contest Period.

UOB reserve the right to disclose and publish the names and any other particulars of the winners, including photographs and testimonies of these winners, for publicity purposes, and by participating in the Contest, the winners agree to co-operate with, attend any prize presentation, if required by UOB, and participate in any advertising, promotional and publicity activities without any payment or compensation.
