RULES AND REGULATIONS

1 OBJECTIVES

- 1.1 The following are objectives of the 29th UOB Painting Of The Year Competition (the “Competition”):
- to promote a greater interest in art,
  - to further encourage artists in their creative endeavours; and
  - to provide a platform to recognise and exhibit the best creative works.

2 ELIGIBILITY

- 2.1 The Competition is open to all Singapore Citizens, Permanent Residents, Employment Pass, Work Permit, Student Pass, Dependent’s Pass and Long Term Visit Pass holders. Participation in the Competition is free-of-charge.

3 THE COMPETITION

- 3.1 The Competition, organised by United Overseas Bank Limited (“UOB”), is divided into three sections: **Open Section, Youth Section and Junior Section.**

- 3.1a The **Open Section** accepts submissions for all two-dimensional works of art in any medium, and is categorised as any one of the following:

Painting

• Abstract

This category is defined as a style of art creation whereby concepts, emotions or meanings are expressed purely with lines, forms, colours and/or materials as key elements and void of any figurative representation of objects, people and nature.

• Representational

This category is defined as a style of art creation whereby the imagery depicts immediately recognisable objects, people or nature.

• Ink Painting

This category is defined as a medium and technique of art creation that requires the use of traditional Chinese brushes, inks, colours and paper or silk.

Photography

This category is defined as a medium and process of art creation that involves the capturing of imagery using digital or non-digital cameras and the reproduction of images onto a two-dimensional ground or surface. Darkroom or digital manipulation is allowed.

An entrant may participate in more than one category.

- 3.1b The **Youth Section** is open to all those who were born between **1992 and 1997** (the “**youth entrant**”).

- 3.1c The **Junior Section** is open to all those who were born between **1998 and 2003** (the “**junior entrant**”).

- 3.2 **The parent or legal guardian of the junior and youth entrant must consent to the entrant’s participation in this Competition in the entry form and agree to these rules and regulations.**

- 3.3 Paintings in acrylic, batik, Chinese brush, collage, crayon, ink, mixed media, oil, watercolour or any other media are accepted. However, **paintings submitted must be original and should not have been created more than two years prior to the submission date. Entrants should not submit works that have been offered for sale, published, entered in previous competitions or exhibited in any form, including online exhibitions.**

- 3.4 Paintings submitted should be **two-dimensional**, of reasonable size, and **properly framed**. Paintings **over 180 cm in height or width (inclusive of their frames) will not be accepted.**

- 3.5 Photography entrants may submit unique photographs based on any subject or theme. Photographs can derive from film or digital formats. Manipulation by darkroom or image processing software is allowed. Digital photographs must be submitted together with digital files of high resolution original images of no less than 2000x1600 pixels, failing which, entries will be disqualified. Non-digital photographs must be submitted with the original negatives or transparencies.

- 3.6 Photographs submitted should have a **minimum size of 8R/Super 8R** and should be **properly framed or mounted on a hard cardboard**. Photographs **over 180 cm in height or width (inclusive of their frames) will not be accepted.**

- 3.7 **Only photographs created within two years prior to the submission date will be accepted. The photographs should not have been offered for sale, published, entered into previous competitions, or exhibited in any form, including online exhibitions. Entrants of winning photography entries should not reproduce signed editions of their works in any size or form.**

4 SUBMISSION OF ENTRIES

- 4.1 Each entrant may submit **a maximum of three entries.**

- 4.2 All entries must be accompanied by **an official registration form and a write-up of not more than 200 words on each entry.** Only one registration form (photocopies accepted) is required per entrant. **The official registration form and write-up(s) must be stapled together.**

- 4.3 Each entry must have a **label** (provided with the registration forms) **attached at the top right-hand corner of the back of the entry.** All information must be clearly **written in block letters** on the labels.

- 4.4 Paintings that have not dried completely will not be accepted.

- 4.5 Entries should be submitted at the **Visual Arts Seminar Room, Level 2, Nanyang Academy Of Fine Arts Campus 1 (Wing B), 80 Bencoolen Street, Singapore 189655 on Sunday, 4 July 2010 (“Submission Date”)** between **1pm and 6pm.**

规则

1 宗旨

- 1.1 第29届大华银行全国绘画比赛旨在增进人们对美术的兴趣、奖励并表彰艺术爱好者的创作努力。

2 参加资格

- 2.1 凡新加坡公民、永久居民、就业准证、工作准证、学生准证、直系亲属证及长期探访证持有者都可以免费参加这项绘画比赛。

3 参赛细则

- 3.1 这项绘画比赛由大华银行举办并分为三组: **公开组、青少年组及儿童组。**

- 3.1a **公开组**接受以任何媒体提呈的平面作品，并分为下列组别：

绘画

• 抽象画组

这项组别是指纯粹以线条、形状、色彩及/或材料为主要元素来体现其概念、情感或含义而毫无任何物体、人物或自然景象比喻陈述的美术创作方式。

• 具象画组

这项组别是指意象即刻描绘出可识别的物体、人物或自然景象的美术创作方式。

• 水墨画组

这项组别是指以传统中国毛笔、水墨、颜料和纸或丝作为媒介和应用技术的艺术创作。

摄影作品

这项组别即是以数码或非数码相机捕捉意象并以二维版面或平面体现现象作为美术创作的媒介及过程。准许以暗室或数码处理。

一名参赛者可参加超过一项组别。

- 3.1b **青少年组**公开给**1992年至1997年**出生的青少年参加（“**青少年参赛者**”）。

- 3.1c **儿童组**则供**1998年至2003年**出生的儿童参加（“**儿童参赛者**”）。

- 3.2 **儿童及青少年参赛者的家长或监护人必须按照大华银行所立的条款及在参加表格上批准及同意该参赛者参加此项比赛。**

- 3.3 举凡胶彩、蜡染、彩墨、拼贴、蜡笔、水墨、混合媒介、油彩、水彩等任何媒介的画作均可参加。但，**画作必须是原创画作而且是截至提交日期前两年内的创作作品。参赛者不得提交已出售、出版、曾参赛或以任何方式展示，包括已在线上展览的作品。**

- 3.4 参赛作品必须是平面画，以适当大小为宜，并需妥当装框。画幅的大小包括画框，高度与宽各不得超过180公分。

- 3.5 摄影参赛者可提交以任何题材或主题的独特摄影照片参赛。照片可出自胶卷或数码方式并允许以暗室或图像处理软件处理。数码摄影作品必须连同不低于2000x1600 像素的高解析度原始影像数码档案一起提交，否则作品将失去参赛资格。非数码摄影照片必须连同原来的底片或幻灯片一起提交。

- 3.6 提交的摄影作品，尺寸不得小于8R/超8R并应妥当装框或装裱在硬板上。摄影作品的大小包括画框，高度与宽各不得超过180公分。

- 3.7 **只有在截至提交日期前两年内创作的摄影作品才会被接受。它们也不得是已出售、出版、曾参赛或以任何方式展示，包括已在线上展览的作品。得奖摄影作品的优胜者不得以任何尺寸或方式复制其作品的签名版。**

4 提交参赛作品

- 4.1 每位参赛者只限以**最多三幅作品**参加比赛。

- 4.2 所有参赛作品必须附有**正式参加表格**，而每件作品须附上**不超过200字**的简介。每位参赛者只需填写一份参加表格（影印本也可）。参赛表格和简介须以**订书钉钉在一起**。

- 4.3 每幅作品须有一个**标签**（随申请表格附上），以**英文大写字母填写清楚，粘贴在作品背面右上角**。

- 4.4 未干的作品将不被接受。

- 4.5 参赛作品必须于**2010年7月4日（星期日），下午1时至6时**，送交至**南洋艺术学院二楼研讨室 (Visual Arts Seminar Room, Level 2, Nanyang Academy Of Fine Arts Campus 1 (Wing B), 80 Bencoolen Street, Singapore 189655 )** 的参赛作品接收处。

## 5 PRIZES

5.1 The four categories of prizes, in the form of UOB Cash Vouchers, are as follows:

**A. UOB Painting Of The Year Award** \$30,000 and a Trophy  
In addition, a bonus prize of a 1-month Residence Programme at the Fukuoka Asian Art Museum may be awarded to the UOB Painting Of The Year winner whom, in the judges' final and conclusive opinion, has submitted an entry of exceptional standard. The winner, if awarded this Residence Programme, has to attend the Programme within 6 months of the awards ceremony.

Only entrants from the Open and Youth Sections are eligible for the UOB Painting Of The Year Award.

**B. Most Promising Young Artist Award**  
• Youth Section \$2,500 and a Trophy  
• Junior Section \$2,000 and a Trophy

**C. Platinum Awards** \$10,000 each  
The four Platinum Awards may be won by any entrant regardless of Category (Abstract, Representational, Ink Painting or Photography) or Section (Junior, Youth or Open) of submission.

**D. Highly-commended Awards for each Section**  
• Three awards for the Open Section \$2,500 each  
• Three awards for the Youth Section \$1,000 each  
• Three awards for the Junior Section \$500 each

5.2 Each entrant is eligible for one award only.

## 6 COPYRIGHT/INTELLECTUAL PROPERTY

6.1 All submission materials submitted to UOB in accordance with these rules and regulations must be original works of the entrant. The entrant must also be the owner of all submitted materials.

6.2 All 16 award-winning entries above, including the documents and materials submitted to UOB, shall be the sole property of UOB. UOB reserves the right to retain all winning artworks and any supporting documentation. Entrants are advised to photograph their submissions for their own records prior to submission.

6.3 All winners shall grant UOB unlimited worldwide, royalty-free, exclusive licence to exhibit, archive and reproduce images of their winning entries (including, but not limited to brochures, calendars, catalogues, greeting cards, websites).

6.4 Each entrant undertakes to indemnify and hold harmless UOB and its officers and agents from and against any and all liability, loss, damage, costs and expenses in relation to any claim or action brought against UOB or its officers and agents arising out of a breach of this warranty.

## 7 JUDGING & COMPETITION RESULTS

7.1 Entries will be judged by a panel of local and/or overseas artists/art connoisseurs/art critics/curators or other creative professionals appointed by UOB in its absolute discretion. The decision of the judges is final. No correspondence will be entered into on this subject before, during, and/or after the Competition.

7.2 UOB reserves the right not to award any of the stipulated prizes should entries fail, in the judges' opinion, to meet the required standards.

7.3 All award winners will be **notified by phone on Thursday, 8 July 2010.**

7.4 Prizes will be presented to all winners at the Opening Ceremony of the Exhibition at **Esplanade Recital Studio at 11am on Saturday, 10 July 2010.**

## 8 EXHIBITION OF ENTRIES

8.1 All award-winning entries will be exhibited at the 29th UOB Painting Of The Year Exhibition (the "Exhibition") which will be held at **Jendela (Visual Arts Space), Esplanade - Theatres on the Bay, 1 Esplanade Drive, Singapore 038981, from 11 to 25 July 2010.**

## 9 RETURN OF ENTRIES

9.1 **With the exception of the award-winning entries which will be exhibited, all other entries must be collected on Sunday, 11 July 2010 from the Visual Arts Seminar Room, Level 2, Nanyang Academy Of Fine Arts Campus 1 (Wing B), 80 Bencoolen Street, Singapore 189655 between 1pm and 5pm. Entries not collected by 5pm on 11 July 2010 shall become the property of UOB who may then dispose of them in whatever way it deems fit.**

## 10 ACCEPTANCE OF RULES AND REGULATIONS

10.1 Submission of entries signifies acceptance of the rules and regulations of the Competition. Whilst all possible care will be taken of the entries submitted, UOB, however, assumes no responsibility for any loss of or damage to the entries before, during, and/or after the Competition.

## 11 GENERAL

11.1 These rules and regulations shall be governed by Singapore law and the entrant hereby agrees to submit to the non-exclusive jurisdiction of the courts in Singapore and consent to service of process by mail or in any other manner permitted by the laws of Singapore.

11.2 A waiver (whether expressed or implied) by UOB of any of the provisions of these rules and regulations or of any breach of or default by an entrant in performing any of those provisions shall not constitute a continuing waiver and that waiver shall not prevent UOB from acting on any subsequent breach of or default by the entrant under any of the provisions of these rules and regulations.

11.3 None of these rules and regulations shall be enforceable under the Contracts (Rights of Third Parties) Act (Cap 53B) by a person who is not a party to it.

## 5 奖金

5.1 奖金以大华银行现金券颁发。四组奖金如下：

**A. 最佳画作奖** 30,000元及奖座一台  
另加额外奖是为时一个月的福冈亚洲美术馆驻馆计划或颁予最佳画作奖得主，视乎于评判团的最终决定，认为获奖作品具备卓越的水准。若获颁此驻馆计划，优胜者必须于颁奖礼后六个月内履行该计划。

只有公开组及青少年组的参赛者可争夺最佳画作奖。

**B. 最佳新秀艺术奖**  
• 青少年组 2,500元及奖座一台  
• 儿童组 2,000元及奖座一台

**C. 四份白金奖项** 10,000元（每份）  
所有儿童组、青少年组或公开组参赛者，无论组别（抽象画组，具象画组，水墨画组及摄影作品组）均有资格赢取这四份白金奖项。

**D. 优等奖**  
• 三份公开组 2,500元（每份）  
• 三份青少年组 1,000元（每份）  
• 三份儿童组 500元（每份）

5.2 所有参赛者只可赢取以上一份奖金。

## 6 版权/知识产权

6.1 所有依据规则提交大华银行的作品必须是参赛者的原创作品。参赛者也必须是所有提交作品的持有人。

6.2 以上所有16份获奖作品，包括提交大华银行的文件及资料归大华银行所有。大华银行有权保留所有获奖参赛作品及任何证明文件。谨请参赛者在提交作品之前将作品拍摄下来，以做为私人记录。

6.3 所有获奖者将无限准许大华银行对获奖作品的影像在世界各地专用及免税展出、归档及复制（包括但不限于手册、日历、编目、贺卡、网站）。

6.4 每位参赛者同意对大华银行及其职员与代理人给予保障及不要求负责因不遵守本保障而对大华银行及其职员与代理人提出赔偿或采取行动的任何及所有责任、损失、损伤，成本及费用。

## 7 评判及比赛结果

7.2 如果评判团认为参赛作品未达预期的水准，大华银行有权不颁发所宣布的任何奖金。

7.3 所有获奖者的参赛者将于**2010年7月8日（星期四）获得电话通知。**

7.4 各奖项将于**2010年7月10日（星期六）上午11时在滨海艺术中心的Esplanade Recital Studio**举行的该画展开幕仪式上颁发予得奖人。

## 8 得奖佳作的展出

## 9 领回参赛作品
