

<u>GET S\$30 WORTH OF FREE FUEL IN SMART\$ AT SHELL</u> <u>TERMS AND CONDITIONS</u>

1 <u>Eligibility</u>

1.1 Subject to Clauses 1.2 and 1.3, GET S\$30 WORTH OF FREE FUEL IN SMART\$ AT SHELL ("the Promotion") is applicable only to recipients of the Direct Mailer for the Promotion and who are also required to be eligible principal cardmembers of UOB Credit and UOB NOW Debit Cards (collectively "Principal Cardmembers" or each a "Principal Cardmember" and such cards to be known collectively as "UOB Cards" or each an "UOB Card") which are valid, subsisting and in good standing as may be determined by United Overseas Bank Limited ("UOB") at its sole and absolute discretion (collectively "Eligible Cardmembers" or each an "Eligible Cardmember").

For the avoidance of doubt, (a) the benefit of all charges incurred by a supplementary Cardmember in respect of the Promotion shall accrue to the Eligible Cardmember; (b) termination of a supplementary Cardmember's account will not by itself disqualify the Eligible Cardmember from the Promotion.

1.2 The following are not eligible for the Promotion:

1.2.1 Principal Cardmembers whose accounts are terminated between 22 July 2009 and 30 September 2009 (both dates inclusive);

1.2.2 Persons who are or become insane, deceased, and insolvent or have legal proceedings of any nature instituted against them;

1.2.3 Any accounts that are deemed to be delinquent or unsatisfactorily conducted at UOB's sole and absolute discretion; and

1.2.4 Any other persons as UOB may decide to exclude at its sole and absolute discretion without notice and without furnishing any reason.

- 1.3 This Promotion is not applicable to UOB JCB card, UOB CUP Card, Bank 121 Card, Travel Accounts, Purchasing and Private Label card; and purchases at Shell Autoserv.
- 2 <u>Promotion Period</u>
- 2.1 The Promotion Period for this Promotion commences on 22 July 2009 and ends on 30 September 2009 (both dates inclusive).
- 3 Allocation of S\$30 Worth of Free Fuel In SMART\$
- 3.1 S\$30 worth of Free Fuel in SMART\$ for redemption at Shell has been issued to every Eligible Cardmember's UOB Card designated and decided by the Bank.
- 3.2 Only 5 SMART\$ can be redeemed during each transaction when you charge a minimum of S\$50 nett purchase to your designated UOB Card.
- 3.3 The 30 SMART\$ issued will expire on 30 September 2009. All unused SMART\$ issued for this Promotion is non-transferable and cannot be exchanged for cash, partially or wholly.



4 <u>General</u>

- 4.1 The decisions of UOB on all matters relating to the Promotion are final, conclusive and binding. UOB shall not be obliged to give any reason or enter into any correspondence with any persons on any matter concerning the Promotion.
- 4.2 Notwithstanding anything in these Terms and Conditions, UOB reserves the right at any time in its absolute discretion to determine and/or amend, by addition to, subtraction from or variation of, these Terms and Conditions without prior notification, including but not limited to the eligibility terms and criteria, the selection of the Eligible Cardmembers and the Eligible Cardmember's designated UOB Card for the Promotion, and the timing of any act to be done, and all participants shall be bound by these amendments.
- 4.3 In the event of any inconsistency between these Terms and Conditions and any advertising, promotional, publicity and other materials relating to or in connection with the Promotion, these Terms and Conditions shall prevail.
- 4.4 A person who is not a party to any agreement governed by these Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any term of such agreement.
- 4.5 These Terms and Conditions shall be governed by the laws of Singapore, and all Eligible Cardmembers who participate in the Promotion shall be deemed to have agreed to submit to the exclusive jurisdiction of the Singapore Courts.
