- 2 To be eligible for this Draw, customer must have bought and paid for an Insure & Travel policy (herein known as Policy) via UOB Personal Internet Banking between 8 March 2010 and 4 April 2010 (both dates inclusive).
- 3 Each approved and fully paid Policy is eligible for one (1) qualifying chance, whether the Policy is a Per Trip Plan or an Annual Plan.
- 4 Staff of UOI or UOB Group and their immediate family members (ie. spouse and children) are not eligible for the Draw.
