

Terms and Conditions
UOB 80th Anniversary Savings Promotion (9 October 2015 to 31 December 2015)

1. Definition

- 1.1 **“Account”** means any UOB Passbook Savings Account, UOB Uniplus Account, UOB One Account, UOB Wealth Premium Account, UOB High Yield Account and UOB Global Currency Premium Account which is in good standing at all times during the Promotion as determined by the Bank at its absolute discretion.
- 1.2 **“Accountholder”** means holder(s) of either one of these accounts, UOB Passbook Savings Account, UOB Uniplus Account, UOB One Account, UOB Wealth Premium Account, UOB High Yield Account and UOB Global Currency Premium Account.
- 1.3 **“Account Balance”** means the day-end balance of an Account before participating in this Promotion. “Day-end balance” for the Account shall be determined by the Bank in its sole and absolute discretion based on the last outstanding balance of the Account on the relevant day.
- 1.4 **“Anniversary Gift”** means the anniversary gift (UOB Limited Edition 1935 Straits Settlements Commemorative Note) as stipulated in the table at Clause 2.2.
- 1.5 **“Bank”** means United Overseas Bank Limited (**“UOB”**) or Far Eastern Bank Limited (**“FEB”**) as the case may be, and includes any successor or assign of the Bank.
- 1.6 **“Fresh Funds”** means (i) funds in the form of non-UOB/FEB cheques; (ii) other funds that are not transferred from any existing UOB/FEB current/savings or fixed deposit account; or (iii) other funds that are not withdrawn from any existing UOB/FEB current/savings or fixed deposit account and re-deposited (whether part or all of the amounts withdrawn) into the Account within the Promotion Period.
- 1.7 **“Promotion”** means the UOB 80th Anniversary Savings Promotion (9 October 2015 to 31 December 2015).
- 1.8 **“Promotion Period”** means the period from 9 October 2015 to 31 December 2015, both dates inclusive.
- 1.9 **“Terms and Conditions”** means the terms and conditions governing the Promotion, as may be amended from time to time.
- 1.10 **“UOB Global Currency Premium Account”** to only include the following currencies to be eligible to participate: United States Dollars, Australian Dollars, New Zealand Dollars and Great British Pounds. To participate in the Promotion, the foreign currency deposited must be in the value of \$50,000 denominated in the applicable foreign currency.

2 Promotion

- 2.1 An Accountholder who fulfills all of the following conditions during the Promotion Period shall be eligible to receive the Anniversary Gift in accordance with the table in Clause 2.2:
- (a) submits a participation form indicating that the Accountholder wishes to participate in the Promotion;
 - (b) deposits a minimum amount of S\$80,000 in Fresh Funds
 - (c) agrees to have the Fresh Funds deposits set out in Clause 2.2 earmarked for a period of **three (3) months** from the date of deposit or earmark, whichever is later. For the avoidance of doubt, eligibility for the Anniversary Gift is subject to the Fresh Funds being successfully earmarked for the specified duration (the **“Earmarked Amount”**).

- 2.2 The Anniversary Gift shall be awarded in accordance with the table below, subject to availability and while stocks last:

- 2.3 Customers may open a new Account at any branch of the Bank in Singapore ("**Bank Branches**") or at any UOB Wealth Banking Centre.

Incremental Fresh Funds deposit can be made using any one of the following channels:-

- (a) UOB Cash Deposit Machine;
 - (b) UOB Quick Cheque Deposit Boxes;
 - (c) Bank Branches over-the-counter;
 - (d) UOB Phone Banking;
 - (e) UOB Internet and Mobile Banking;
 - (f) GIRO; or
 - (g) any other channels permitted by the Bank.
- 2.4 Eligibility to receive the Anniversary Gift is subject to the Fresh Fund deposits being successfully earmarked for the entire Earmarking period. The Anniversary Gift is available on a first come first served basis, whilst stock last.
- 2.5 Each customer is only entitled to receive a maximum of one (1) Anniversary Gift. Each customer shall not be entitled to any additional Anniversary Gifts, notwithstanding that the customer subsequently deposits additional Fresh Funds into the Account during the Promotion Period.
- 2.6 The entitlement to the Anniversary Gift is not transferable or exchangeable for cash, credits or otherwise, unless otherwise permitted by the Bank at its sole and absolute discretion.
- 2.7 The Anniversary Gift must be claimed in Singapore on or before the date indicated on the redemption letter. Any unclaimed Anniversary Gift will be forfeited. Any Accountholder whose Anniversary Gift has been forfeited shall not be entitled to any payment or compensation notwithstanding non-receipt of notification. The Anniversary Gift is not replaceable if lost, damaged or stolen.
- 2.8 The Bank reserves the right to substitute the Anniversary Gift with any item of equivalent or similar value at any time, without notice and without furnishing any reasons.
- 2.9 The Anniversary Gift is provided solely by the merchant and the Bank assumes no liability or responsibility for the acts or defaults of the merchant or defects in the goods or services offered in this Promotion, or for any injury, loss, damage, costs or expenses in connection with or arising out of the redemption or usage of the goods and services offered in this Promotion. The Bank is not an agent of the merchant. Any dispute about the quality or service standard must be resolved directly with the merchant. The merchant may impose conditions for redemption of the goods or services.

3. Withdrawals / Closure of Account

- 3.1 An early account closure fee of S\$30 is payable if an Account is closed within six (6) months from the account opening date of the Account.
- 3.2 The Accountholder agrees and acknowledges that the Bank may at its discretion forfeit or reclaim the Anniversary Gift or charge to and debit an amount equivalent to the value of the Anniversary Gift, if already awarded/redeemed, from the Accountholder's Account, if the Accountholder closes the Account and/or withdraws part of or all of the Earmarked Amount within three (3) months from the date of deposit or earmark, whichever is earlier.
- 3.3 If the monies standing to the credit of the Account are not sufficient to reimburse the Bank for the value of the Anniversary Gift, the Accountholder shall immediately reimburse the Bank for the value of the Anniversary Gift.

4. Interest Rates

- 4.1 Accountholder participating in this Promotion will be entitled to the prevailing interest rates on the Account Balance and the Fresh Fund deposited in his/her Account during the Promotion Period.
- 4.2 Please be informed that the prevailing interest rates on the Accounts are available on www.uob.com.sg.

5. General

- 5.1 The Accountholder will need to maintain sufficient funds in the Account to meet the financial commitments of the Accountholder. The Accountholder continues to be liable for all associated charges arising from any unsuccessful processing of cheques, GIRO deductions or any other payment instructions, whether due to insufficient available funds in the Account or otherwise.
- 5.2 If the Bank subsequently discovers that the Accountholder is in fact not eligible to participate in or does not qualify for the Promotion, the Bank may at its discretion, forfeit or reclaim the Anniversary Gift or charge to and debit an amount equivalent to the value of the Anniversary Gift, if already awarded, from the Accountholder's Account.
- 5.3 The Bank has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Promotion, including but not limited to the determination of whether the Accountholder has met all the requirements of the Promotion. The Bank's decisions shall be final, conclusive and binding on all parties concerned and no payment or compensation will be given or paid by the Bank to any person (including the Accountholder). The Bank shall not be obliged to give any reason or enter into any correspondence with any person on any matter relating to the Promotion or its decision.
- 5.4 Participation in the Promotion is subject to the Terms and Conditions. The Terms and Conditions shall be read in conjunction with the Bank's Terms and Conditions Governing Accounts and Services. In the event of any inconsistency between the Term and Conditions and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, the Terms and Conditions shall prevail.
- 5.5 The Bank may, at any time and at its sole and absolute discretion, vary, amend, delete or add on to any of the Terms and Conditions, including but not limited to varying the Promotion Period or terminating the Promotion at any time without giving any reason or prior notice or assuming any liability to any customers, and all customers shall be bound by these amendments. The Bank shall not be liable for any claims, costs, expenses, losses or damages suffered by any person as a result of the aforementioned matters.
- 5.6 The Promotion is not valid with any other privileges (including but not limited to Bank staff privileges) or promotions unless otherwise stated.
- 5.7 While all the information provided herein is believed to be reliable at the time and date of printing, the Bank makes no representation or warranty whether express or implied, and accepts no responsibility or liability for its completeness or accuracy.
- 5.8 A person who is not a party to any agreement governed by the Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any term of such agreement.
- 5.9 The Terms and Conditions shall be governed by the laws of the Republic of Singapore and the Accountholder shall be deemed to have agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.

Deposit Insurance Scheme

Singapore dollar deposits of non-bank depositors and monies and deposits denominated in Singapore dollars under the Supplementary Retirement Scheme are insured by the Singapore Deposit Insurance Corporation, for up to S\$50,000 in aggregate per depositor per Scheme member by law.

Monies and deposits denominated in Singapore dollars under the CPF Investment Scheme and CPF Minimum Sum Scheme are aggregated and separately insured up to S\$50,000 for each depositor per Scheme member



Addendum to the Terms and Conditions

To participate in the Promotion, the foreign currency deposited must be in the value of \$50,000 denominated in the applicable foreign currency.

In the event of any conflict or inconsistency between any term of this Addendum with any of the Terms and Conditions as supplemented by this Addendum, this Addendum prevail and the Terms and Conditions (as supplemented by this Addendum) shall be deemed to have been amended to the extent necessary to give effect to this Addendum.
