Terms and Conditions

- 1. "Promotion" refers to the UOB CashPlus ATM Withdrawal Promotion.
- 2. The Promotion commences on 1 August 2010 and ends on 30 October 2010 (both dates inclusive) (the "Promotion Period").
- 3. UOB CashPlus accountholders whose accounts are in good standing are eligible to participate in this Promotion ("Eligible Accountholders").
