

UOB – Singapore Airlines A380 Tickets to Tokyo Draw

TERMS AND CONDITIONS

1. Eligibility

1.1 The United Overseas Bank Limited ("UOB") **Singapore Airlines A380 Tickets to Tokyo Draw** (the "Draw") is open to all Eligible UOB Credit or Debit Cardmembers subject to the following conditions.

1.2 Eligibility:

- i. "Eligible Cards" shall mean Visa, MasterCard and American Express credit cards and all debit card accounts with UOB (collectively referred to as "Eligible UOB Cards" and each an "Eligible UOB Card"). For the avoidance of doubt, China Unionpay (CUP) and Japan Credit Bureau (JCB) cards are not eligible cards for this Draw.
- ii. "Eligible Cardmembers" shall mean principal holders of Eligible UOB Cards (collectively referred to as "Cardmembers" and each a "Cardmember") which are valid, subsisting and satisfactorily conducted in the opinion of UOB. The benefit of all charges incurred by a supplementary Eligible Cardmember in respect of this Draw shall accrue to the Eligible Cardmember.
- 1.3 Notwithstanding anything herein, UOB has the absolute discretion at any time and from time to time to determine the eligibility of any Cardmember and shall not be obliged to give any reason therefor. The following persons shall not be eligible for the Draw:
 - Directors or employees and their immediate family members of, United Overseas Bank Ltd, Far Eastern Bank Ltd, Singapore Airlines, Saatchi & Saatchi Singapore (only applicable to staff handling the UOB account), and UOB's and Singapore Airlines' advertising agencies that handle this Draw;
 - ii. Principal Cardmembers whose credit and/or debit card account(s) is/are terminated between the period from 4 February 2010 up to the Draw Date (both dates inclusive):
 - iii. Persons who are of unsound mind, deceased, insolvent or having any legal proceedings of any nature instituted against them;
 - iv. Principal Cardmembers whose accounts are delinquent or unsatisfactorily conducted for any reason as may be determined by UOB in its absolute discretion.

For the avoidance of doubt, termination of a supplementary Credit Cardmember's account will not by itself disqualify the eligible principal Cardmember from the Draw.



2. Qualifying Period

2.1 "Qualifying Period" for the Draw means the period commencing 4 February 2010 to 2 March 2010 (both dates inclusive).

3. Allocation of Chances

- 3.1 One (1) chance will be allotted to every Eligible Cardmember for every \$50 spent in a single transaction when they book with **singaporeair.com** during the Qualifying Period (commencing 4 February 2010 to 2 March 2010 (both dates inclusive)) with their Eligible UOB Card.
- 3.2 UOB shall not be responsible for any failure or delay in the transmission of evidence of sale transactions by MasterCard/Visa Acquiring Merchants, merchant establishments, VISA International Incorporated, postal or telecommunication authorities or any other party(s) which may result in a charge incurred or cash advance made by the Eligible Credit Cardmember and/or his supplementary credit cardmember(s) as being omitted from the allocation of chances by UOB during the Qualifying Period.
- 3.3 The records of transactions of UOB and the total number of chances allocated to an Eligible Credit Cardmember shall be final and conclusive. No correspondence or claims will be entertained.

4. Draw Date

- 4.1 Unless UOB notifies otherwise, the Draw will be conducted on 31 March 2010 or such other date(s) as UOB may determine in their absolute discretion ("the Draw Date"), in the presence of the external auditors of UOB at Singapore Press Holdings Limited, 1000 Toa Payoh North, News Centre, Singapore 318994.
- 4.2 UOB reserves the right to draw reserve winners to substitute any winner subsequently found to be disqualified.
- 4.3 UOB's determination of the winners shall be final, conclusive and binding. No correspondence or claims will be entertained.

5. Prizes

- 5.1 There are a total of **five (5) pairs** of Singapore Airlines A380 Tickets to Tokyo for the Draw ("Prize Tickets"). The following terms and conditions apply:
 - Prize Tickets to be issued by 31 May 2010 with the winner's name(s) and travel date(s).
 - Valid Travel period exiting-Singapore: On/Before 30 September 2010.
 - Minimum Stay of three (3) Days, Maximum Stay of one (1) Month.



- Prize Tickets are all-inclusive of airfare, airport taxes and applicable airport surcharges.
- Two (2) passengers must travel together throughout the journey, without any deviation of any passenger(s) during the journey.
- Tickets are non-transferable once issued.
- Not valid for travel on flight SQ12.
- No mileage accrual or upgrade award redemption is allowed.
- Refund/Cancellation of totally unused or partially used ticket(s) is/are not permitted.
- Date changes are permitted at SGD30 (or at such costs prescribed by, Singapore Airlines from time to time), and subject to the conditions stated in Clause 5.1 herein
- Accompanied Child/ Infant occupying a seat is allowed.
- Unaccompanied Child (under 5 years old) / Unaccompanied Minor (5 years to under 17 years old) / Infant not occupying a seat are not allowed.
- 5.2 The Prize Tickets are neither transferable nor exchangeable for cash or otherwise. UOB shall not be responsible for any consequences including but not limited to loss of life, injury to person and/or loss or damage to property arising from or in connection with the Draw, redemption or use of the Prize Tickets, or travel arising from or in connection with the Prize Tickets.
- 5.3 The winner will be notified by post and/or contacted via telephone based on the last known contact information with UOB Card Centre's records.
- 5.4 UOB may, at any time without notice, in its sole and absolute discretion, substitute any prize stipulated herein, with another prize of similar value (whether in cash or otherwise). UOB's determination of the substituted prize shall be final, conclusive and binding. No correspondence or claims will be entertained.

6. Participation

- 6.1 It is a condition precedent for participation in the Draw that the winner consents to the public disclosure of his/her name, identification/passport number and such other information that may indicate his/her account with UOB and photographs for publicity or commercial purposes or otherwise participate in the publicity activities of UOB in relation to the Draw and to the use of any data provided by such winner for any future marketing effort by the UOB group of companies, without any payment or compensation thereof.
- 6.2 The winner shall, if required by UOB, attend any prize presentation and participate in any advertising, promotional and publicity activities relating to or in connection with the Draw at his/her own costs.



7. General

- 7.1 The decisions of UOB on all matters relating to the Draw are final, conclusive and binding. UOB shall not be obliged to give any reason or enter into any correspondence with any persons on any matter concerning the Draw.
- 7.2 Notwithstanding anything in these Terms and Conditions, UOB reserves the right at any time in its absolute discretion to determine and/or amend, by addition to, subtraction from or variation of, these Terms and Conditions without prior notification, including but not limited to the eligibility terms and criteria, the selection of winners, and the timing of any act to be done, and all participants shall be bound by these amendments.
- 7.3 In the event of any inconsistency between these Terms and Conditions and any advertising, promotional, publicity and other materials relating to or in connection with the Draw, these Terms and Conditions shall prevail.
- 7.4 A person who is not a party to any agreement governed by these Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any term of such agreement.
- 7.5 These Terms and Conditions shall be governed by the laws of Singapore, and all Eligible Cardmembers who participate in the Draw shall be deemed to have agreed to submit to the exclusive jurisdiction of the Singapore Courts.
- 7.6 UOB makes no warranty or representation as to the quality, merchantability or fitness for purpose of the SIA goods and services.
