TERMS AND CONDITIONS FOR UOB CARDS RIMOWA CAMPAIGN 2017 ("PROMOTION")

Eligibility

- 1. This Promotion is only valid between 1 November 2017 and 31 January 2018 (both dates inclusive) ("**Promotion Period**").
- 2. This Promotion is open to an individual who fulfills <u>ALL</u> the following conditions ("**Eligible** Cardmember"):
 - (i) who is the principal holder of a UOB Visa Infinite Card, UOB Privilege Banking Card, or UOB Lady's Solitaire Card (each a "Card") which is issued by United Overseas Bank Limited ("UOB") in Singapore;
 - (ii) who is the addressee of the direct mailer and/or Electronic Short Message Service ("SMS") from UOB inviting him/her to participate in this Promotion:
 - (iii) whose Card account is in good standing and is satisfactorily conducted (as determined by UOB in its discretion);
 - (iv) whose Card account is not voluntarily or involuntarily cancelled, terminated, closed or suspended at any time;
 - (v) who successfully registers himself/herself for this Promotion, within the Promotion Period, by sending an SMS, to 77862 from his/her last known registered mobile number with UOB in the following format "rimowa<space>NRIC Number" ("SMS Registration");
 - (vi) who charges Eligible Transactions amounting to at least S\$60,000 ("Qualifying Amount") to their Card during the Promotion Period; AND
 - (vii) is amongst the top 300 individuals with the highest accumulated amount of Eligible Transactions charged to their Card during the Promotion Period.
- 3. For the purposes of this Promotion:
 - (i) "Eligible Transactions" refer to any retail transactions for the purchase of goods and/or services successfully charged to the Card and which are captured and posted on UOB's systems; but shall exclude Income/Property Tax Payment Facility, UOB Visa Infinite / UOB Privilege Banking and/or other Payment Facilities, posted Instalment Payment Plan (IPP), fund transfer, cash advances, instalment loans, fees, interests, other financial charges, and without limiting the generality of the foregoing, also exclude transactions consisting of / containing the following references:

- (ii) Transactions charged to the **UOB Lady's Solitaire Card**, and which are incurred at establishments which are registered under the following Merchant Category Codes (MCC) will not qualify as Eligible Transactions:
 - 6300 Insurance Underwriting, Premiums
 - 6399 Insurance Default
 - 8398 Organizations, Charitable and Social Service
- 4. UOB reserves the right to amend the list of Eligible Transactions and the list of excluded transactions in its sole discretion and without any prior notice or giving any reasons.
- 5. For the purposes of this Promotion, Eligible Transactions incurred on a supplementary Card will accrue to the respective principal Card and the benefits awarded to that principal holder.
- 6. The Qualifying Amount will be determined in Singapore Dollar Currency and based on UOB's prevailing foreign exchange rates as at the relevant transaction dates of each Eligible Transaction as reflected on the Card statement. .

SMS Registration

- 7. The Eligible Cardmember will receive a confirmation Electronic Short Message Service ("SMS") from UOB once he/she successfully completes the SMS Registration.
- 8. All SMS Registrations must be done via SMS by the Eligible Cardmember with his/her last known registered mobile number with UOB. Only SMS Registrations received by UOB will be considered for the Promotion. Any incomplete or inaccurate SMS Registration will not be considered and consequently be disqualified. For the avoidance of doubt, each Eligible Cardmember is only allowed to register once to participate in the Promotion irrespective of the number of Cards that he/she may have.
- SMS Registration starts from 0000 hours on 1 November 2017 and ends on 2359 hours on 31 January 2018 (Singapore time). SMS entries received by UOB after 2359 hours on 31 January 2018 will not be eligible for the Promotion and will be considered invalid and void.
- 10. Sending and receiving SMS is dependent on a SMS vendor, an independent telecommunication authority or service provider or such other third party which is engaged by UOB for the Promotion and UOB shall not be responsible for any undelivered, lost or delayed SMS sent and/or received by the Eligible Cardmembers. The Eligible Cardmembers shall pay and be solely responsible for all fees and charges imposed by such service providers for the sending and/or receipt of any SMS in connection with this the Promotion.
- 11. The SMS vendor, independent telecommunication authorities or service provider or such other third party is a third party and is independent and beyond the control of UOB. UOB shall not be responsible in any manner whatsoever for their acts or defaults.

Promotion

- 12. Each Eligible Cardmember will qualify to receive a RIMOWA LIMBO Electronic Tag Multiwheel® 73L worth S\$1,350 ("**Gift**").
- 13. Limited to one (1) Gift per Eligible Cardmember, regardless of how many Cards he/she has. Selection of the Gift color is limited to the existing stock availability at the point of redemption, and whilst stocks last.
- 14. The Gift is not transferrable, exchangeable for cash (whether in full or partial), credit, other gifts or benefit of any kind. This Promotion is not valid with any other privileges or promotions unless otherwise stated.
- 15. UOB reserves the right, at its discretion, at any time, without notice or assigning any reason thereof, replace or substitute the Gift with any other gift of equal or similar value selected by UOB.
- 16. A notification letter (the "Letter") with details on the redemption of the Gift will be mailed to the Eligible Cardmember (to his/her last known address based on UOB's records) by 31 March 2018, or by such other mode / form of communication and on such other date that UOB may decide on from time to time.
- 17. The Letter will set out the details and procedures for the redemption of the Gift. The Eligible Cardmember must make the redemption of the Gift within the stipulated timeline; otherwise, the Gift will be forfeited and deemed null and void.
- 18. UOB assumes no liability or responsibility and will not be liable or responsible for any failure or delay in the Eligible Cardmember's receipt of the Letter or any Letter which gets lost or misplaced or tampered with or defaced or stolen or misdirected or damaged in the post or which has expired. Any Letter that is lost, misplaced, defaced, stolen or tampered with, misdirected or damaged is strictly non-replaceable and not exchangeable for cash or otherwise.
- 19. If any Gift remains un-redeemed by the stipulated timeline or if any Eligible Cardmember is subsequently discovered to be ineligible or not entitled to participate in the Promotion, UOB reserves the right to forfeit/reclaim the Gift and award or dispose of it in such manner and to such persons as UOB deems fit without any liability on the part of UOB to any persons. No payment or compensation whether in cash, credit or kind shall be made by UOB for the forfeited/reclaimed Gift. Where the Gift was awarded to / redeemed by an Eligible Cardmember who was subsequently discovered to be ineligible or not entitled to participate in the Promotion, UOB shall be entitled to claim from the Eligible Cardmember a reimbursement for the value of the Gift.
- 20. UOB will not be liable or responsible for any defects, deficiency, quality, merchantability, the fitness or any other aspect of the Gift or any goods or services provided under the Promotion, or the acts or defaults of the merchant, agent, supplier or service provider of the Gift or any goods or services provided under the Promotion.
- 21. UOB is not an agent of the merchants, agents, suppliers, or service providers. Any dispute about the quality or service standard must be resolved directly with the merchants, agents, suppliers, or service providers.
- 22. The merchants, agents, suppliers, or service providers may impose additional terms and conditions for the redemption of the Gift, or goods or services.
- 23. UOB will not be responsible or liable for any injury, loss, claim or damage whatsoever or for any charges, costs or expenses of any kind whatsoever suffered or incurred as a result of the redemption or usage of the Gift or goods or services or in connection with the Promotion howsoever arising. UOB and the participating merchants, agents, suppliers or

service providers reserve the right to vary/amend any relevant terms and conditions without prior notice or giving any reason or being liable to any person. No correspondence, appeal, or claims will be entertained.

General

- 24. UOB reserves the right, at its sole and absolute discretion and at any time and without giving prior notice or any reason, to vary, amend, add or delete any of the terms and conditions herein ("**Terms and Conditions**") without assuming any liability to any person, and the Eligible Cardmembers shall be bound by these variations, amendments, additions or deletions.
- 25. Participation in the Promotion is subject to these Terms and Conditions and the Eligible Cardmembers are deemed to have accepted these Terms and Conditions when they participate in the Promotion. The Eligible Cardmembers shall indemnify UOB for any claims, expenses, actions, losses or damages or costs (including legal costs on a full indemnity basis) made against or incurred or sustained by UOB in connection with any breach of these Terms and Conditions.
- 26. Additionally, all Eligible Cardmembers shall continue to be bound by the terms and conditions set out in the UOB Cardmember Agreement (available at uob.com.sg/personal/cards/credit/tnc.html) ("Standard Terms"). In the event of any inconsistency between these Terms and Conditions and the Standard Terms, these Terms and Conditions shall prevail to the extent of such inconsistency on matters relating to this Promotion.
- 27. UOB shall not be liable if it is unable to perform its obligations under these Terms and Conditions, due directly or indirectly, to the telecommunication authorities, to any machine or communication system to any merchant, or service provider or such other third party which maybe engaged for the Promotion, industrial dispute, war, Act of God, or anything outside the control of UOB.
- 28. UOB shall not be responsible for:-
 - (i) any failure or delay in the transmission of the Eligible Transactions, sale transactions or receipt of evidence of sale transactions by acquiring merchants, merchant establishments, card associations, postal or telecommunication authorities or any other parties which may result in a charge made by the Eligible Cardmember being omitted (whether from being posted to the Eligible Cardmember's Card account and/or captured in UOB's system or otherwise) during the Promotion Period;
 - (ii) for any late posting of the Eligible Transactions or for any failure in the Eligible Transactions being transacted by the Eligible Cards or being captured in UOB's system or
 - (iii) for any breakdown or malfunction in any computer system or equipment.
- 29. UOB shall not be responsible for any loss to or expenses of any Eligible Cardmember or any other person in connection with the Promotion, howsoever arising.
- 30. UOB's decision on all matters relating to this Promotion shall be final, conclusive and binding on the Eligible Cardmember. UOB shall not be obliged to give any reason or enter into any correspondence with the Eligible Cardmember or any persons on any matter concerning this Promotion and no appeal, correspondence or claims will be entertained.
- 31. Notwithstanding anything in these Terms and Conditions, UOB reserves the right at any time and from time to time in its absolute discretion to terminate the Promotion or to determine and/or amend, by adding to, subtracting from or varying of, any of the Terms and Conditions herein, including but not limited to varying the Promotion Period, the eligibility terms and criteria, and the timing of any act to be done, without giving any

- reason or prior notice or assuming any liability to any Eligible Cardmember, and all Eligible Cardmembers shall be bound by these amendments.
- 32. While all information provided herein is believed to be correct and reliable at the time of publishing or posting online, UOB makes no representation or warranty whether express or implied, and accepts no responsibility or reliability for its completeness or accuracy.
- 33. A person who is not a party to any agreement governed by these Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce or enjoy the benefit of any term of such agreement.
- 34. These Terms and Conditions shall be governed by the laws of the Republic of Singapore and all Eligible Cardmembers who participate in this Promotion shall be deemed to have irrevocably agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
