

## Terms & Conditions for the Marine Life<sup>™</sup> Passes Giveaway:

- 1. Promotion is open to:
  - i) New UOB Principal applicants who are not holding any active UOB Principal Credit Card and UOB CashPlus account;
  - ii) New UOB Supplementary Card applicant who are not holding any active UOB Credit Card;
