

## Terms and Conditions - UOB SME Exchange Promotion

1. Under the UOB SME Exchange Promotion (“**Promotion**”), each of the SME Exchange Offers (each an “**Offer**” and collectively the “**Offers**”) listed below:-
  - (i) is provided by the applicable merchant(s)/provider(s) listed in the table below (collectively “**Providers**” and each a “**Provider**”);
  - (ii) are subject to the terms and conditions of the Promotion and the applicable Provider’s terms and conditions of the applicable Offer and which any such terms and conditions may be amended by United Overseas Bank Limited (“**UOB**”) or the Provider at any time and from time to time at their absolute discretion and without any reason or prior notice and without being liable to any person;
  - (iii) is valid until 31 December 2017, 2359 hours (or such other date as set out in the prevailing terms and conditions of the applicable Offer) and is provided on a “*first come, first served*” basis and a “*while stocks last*” basis;

    - (b) has prior to the submission of the applicable Registration Form, has entered the applicable “*Promotion Code*” in connection with that Offer, if applicable, into the Registration Form – the applicable “*Promotion Code*” is indicated in the relevant marketing copy of the Promotion;
    - (c) is contacted by the applicable Provider to receive/use/redeem/claim/enjoy that Offer; and
    - (d) has also fulfilled the applicable Provider’s eligibility criteria (if any) to receive/use/redeem/claim/enjoy such Offer;
  - (v) are listed in Singapore Dollars, unless stated otherwise and may be subject to prevailing government taxes and service charges, where applicable and UOB will not be responsible or liable to any party or person for any payments for the Offers and the goods and services and/or the prevailing government taxes and service charges.
