

<u>Terms and Conditions Governing The UOB Win A BMW 2 Series Active Tourer 218i At Caltex Lucky Draw 2015</u>

1 Eligibility

- 1.1 The United Overseas Bank ("UOB") Win A BMW 2 Series Active Tourer 218i At Caltex Lucky Draw 2015 ("the Draw") is open to Eligible Participants (as defined below) subject to the following Terms and Conditions. Participation in the Draw is deemed acceptance of these Terms and Conditions.
- 1.2 <u>Eligible Participants</u>: All existing and new principal holders of UOB Cards issued in Singapore which are valid, subsisting and in the opinion of UOB in good standing and satisfactorily conducted, and who perform an Eligible Transaction.
- 1.3 <u>Eligible Transaction</u>: A petrol spend of every S\$50 nett per transaction which is charged to a UOB Card at any Caltex Stations during the Qualifying Period. Eligible Transaction must be posted and captured in UOB's system during the Qualifying Period to qualify for the Draw. Eligible Transaction made by a supplementary cardmembers shall accrue to the benefit of the Eligible Participant for the purpose of the Draw.
- 1.4 Qualifying Period: The period of time commencing at 00:00 on 1st July 2015 to 23:59 on 31th August 2015 (both dates inclusive).
- 1.5 Without limiting the generality of the above, the following persons shall not be eligible for the Draw:
 - (a) Directors or employees/staff of UOB or any of UOB's subsidiaries during the Qualifying Period (as defined below) and their immediate family members:
 - (b) Employees and staff of any auditors, advertising agency, promotion agencies and/or other persons involved (directly or indirectly) in organizing, promoting and/or conducting the Draw and their immediate family members;

2 Lucky Draw – Entry

- 2.1 The chances for the Draw shall be allocated in the following manner:
 - One (1) chance will be allocated to every Eligible Participant for every Eligible Transaction during the Qualifying Period.
- 2.2 Notwithstanding the foregoing, UOB has the absolute discretion to effect any adjustment, forfeiture or disqualification of the chances allocated for the Draw. UOB's determination of the allocation shall be final and conclusive.

3 Lucky Draw – Draw Date and Prizes

- 3.1 Unless UOB notifies otherwise, the Draw will be conducted on 17th September 2015, at 11:00 am at UOB 480 Toa Payoh Lorong 6 #25-01 HDB Hub East Wing Singapore 310480 or on such other date or time or at such other venue as may be determined by UOB at its sole discretion.
- 3.2 The prize for the Draw is a demonstrator BMW 2 Series Active Tourer 218i (with 3,000 miles on the odometer) worth S\$78,000 excludes Certificate of Entitlement (COE), Motor vehicle Insurance, road tax, registration number plates, In-Vehicle-Unit (IU) and registration fees. Demonstrator car specifications and colour may vary from the model shown.
- 3.3 The winner will be drawn at random. UOB reserves the right to draw an eligible reserve winner to substitute any winner subsequently found to be ineligible or disqualified. UOB's determination of the winner shall be final, conclusive and binding.
