

TERMS AND CONDITIONS FOR UOB CARDS SPEND AND GET 2017 PROMOTION

- The UOB Cards Spend and Get 2017 Promotion ("Promotion") is applicable to anyone who is a principal or supplementary holder of a United Overseas Bank Limited ("UOB") personal credit or debit card issued in Singapore and whose card account(s) is/are valid, subsisting, in good standing and satisfactory conducted in the opinion of UOB ("Participants").
- 2. The Promotion is available from 18 August 2017 to 31 December 2017, both dates inclusive ("**Promotion Period**").
- The first 1000 Participants who perform Eligible Transactions of at least \$2,200 ("Minimum Spend") during the Promotion Period will be deemed "Eligible Participants" who are eligible to redeem a duffel bag (the "Gift")
- 4. The Minimum Spend must be incurred within 3 charge slips issued from the same Participating Merchant in the name of the Eligible Participant.
- 5. For the purposes of this Promotion, the Eligible Transactions performed by a supplementary holder **will not** accrue to the respective principal holder and will not form part of the principal holder's Eligible Transactions, and vice versa.
- 6. In this Promotion:
 - (i) "Eligible Transactions" shall mean any non-online transaction(s) carried out in Singapore for travel booking/purchases at any of the Participating Merchants which are successfully carried out on and charged to the Eligible Participant's UOB credit or debit card account and which are successfully captured/posted on UOB's systems during the Promotion Period, and which are evidenced by charge slips, sales slips or receipts.

- 7. Each Eligible Participant is limited to one Gift.
- 8. The Gifts are available and redeemable on a first come first served basis, while stock last. Redemption period commences from 18 August 2017 to 31 December 2017 at Mojito Redemption Centre (Address: Plaza Singapura Extension, 68 Orchard Road #04-60/61, Singapore 238839. Tel: 6534 8095). For the avoidance of doubt, the Gift will be forfeited if the Eligible Participant does not redeem the Gift by 31 December 2017. No payment or compensation will be given or paid by UOB for any forfeited Gift.
- 9. To redeem the Gift, the Eligible Participants have to present the original charge slip(s) of Eligible Transaction(s), the corresponding original UOB credit and/or debit card and their original Identity Cards or Passport for verification at Mojito Redemption Centre.
- 10. The colour of the Gifts shall be determined at the discretion of UOB and the merchant. The Gifts are not transferrable or exchangeable for cash, credit or other gifts or otherwise in full or in part. No payment or compensation whether in cash, credit or in kind shall be made for any unredeemed, uncollected, lost, misplaced, defaced, stolen or damaged Gifts.
- 11. The Gifts are provided solely by the merchant, manufacturer and/or supplier. UOB assumes no liability or responsibility for the acts and defaults of the merchant, manufacturer and supplier; defects in the Gift, and goods and services offered in the Promotion or for any injury, loss, damage, costs or expenses in connection with or arising out of the redemption or usage of the Gifts or goods and services offered in this Promotion.
- 12. UOB is not an agent of the manufacturer, merchants and/or suppliers of the Gifts or the goods or services offered in the Promotion. Any dispute about the quality or service standard must be resolved directly with the respective manufacturer, merchants and/or suppliers.
- 13. The manufacturer, merchants and/or suppliers of the Gifts may impose conditions for the redemption of the Gifts and/or the goods or services offered in the Promotion.
- 14. Notwithstanding anything herein, UOB and Mojito Redemption Centre have the sole and absolute discretion at any time and from time to time to determine the eligibility of any Eligible Participants for this Promotion and shall not be obliged to give any reason therefor.

If the Eligible Transaction is subsequently cancelled for any reason whatsoever or if there was a repeated redemption using the same Eligible Transactions for the Promotion or if it has been determined by UOB that the Eligible Participant has breached any of the terms of the Promotion, UOB reserves the right to forfeit the Gift, or if already redeemed by the Eligible Participant, reclaim and charge the full retail value of the Gift(s) from the Eligible Participant.
- 16. UOB reserves the right, at its discretion, at any time, without notice or assigning any reason thereof, replace or substitute the Gifts with any other item of equal of similar value selected by UOB. UOB's determination of the replaced and/or substituted item shall be final, conclusive and binding.

UOB shall not be responsible for (i) any failure or delay in the transmission of card transactions by Visa International/MasterCard/American Express/CUP, acquiring merchants for the foregoing, merchant establishments, postal or telecommunication authorities or any other parties which may result in a transaction made by the Eligible Participants being omitted during the Promotion Period; (ii) any late posting of the transactions and thereby affecting the Eligible Participant's eligibility for this Promotion or the Gifts; (iii) for any notice or communication which gets lost, misplaced, defaced, tampered with, stolen, damaged or misdirected in the post; (iv) for any breakdown or malfunction in any computer system or equipment; (v) if the Bank is unable to perform its obligations hereunder as a result of (whether direct or indirect) the delay or failure of any third party including, but not limited to, the SMS vendor, telecommunication authorities or service provider, the failure of any machine, computer system or communication system, industrial dispute, war, Act of God or for any act or omission outside the control of the Bank; or (vi) for any cost, damage, claim of, loss to or expenses of the Participant or any other person in connection with the Promotion, howsoever arising.
- 18. UOB reserves the right to at any time in its sole and absolute discretion to amend, vary, add or delete any of the terms and conditions of this Promotion for any reason and without prior notification without assuming any liability to any person, and the Participants shall be bound by these amendments.
- 19. UOB's decision on all matters relating to this Promotion shall be final, conclusive and binding on the Participants. UOB shall not be obliged to give any reason or enter into any correspondence with the Participants or any persons on any matter concerning this Promotion.
- 20. All information is correct at the time of publishing and UOB makes no representation or warranty whether expressed or implied, and accepts no responsibility or liability for its completeness or accuracy.
- 21. Participants will be subjected accordingly to the prevailing terms and conditions under the UOB Cardmember Agreement ("Standard Terms"). Participants are deemed to have accepted the terms and conditions herein when they participate in this Promotion.
