

## Terms and Conditions of the UOB USB Mobile Phone Charger Giveaway

- 1. The United Overseas Bank Limited ("UOB") USB Mobile Phone Charger Giveaway (the "Promotion") is open to all Eligible Customers as herein described.
- 2. Eligible Customers refer to all customers of UOB who maintain a Personal Internet Banking ("PIB") Account and who, during the Qualifying Period (defined in 1.4) perform the activity via PIB as listed in 1.5.
- 3. Employees of UOB, FEB, advertising agencies and anyone directly connected with the promotion are not eligible. Notwithstanding anything herein, UOB has the absolute discretion at any time and from time to time to exclude an otherwise Eligible Customer and shall not be obliged to give any reason therefor.
- 4. The Qualifying Period is from 1 April 2005, Friday, to 30 June 2005, Thursday (both dates inclusive).
- 5. Only the first 200 Eligible Customers (the "Winners") who perform a first-time login to UOB Personal Internet Banking each week during the Qualifying Period will be entitled to one (1) USB Mobile Phone Charger (the "Prize").

- 7. Eligible Customers who have terminated their UOB PIB 6 months prior to the Qualifying Period will not be eligible for the Prize when they re-apply for UOB PIB during the Qualifying Period.
- 8. The Winners will be notified by post at the end of the Qualifying Period.
- 9. The Prize shall not be exchangeable, transferable or substituted for cash or otherwise, in all cases, whether in whole or in part. UOB does not warrant the quality, \*performance or fitness for purpose of any of the Prizes and shall not be

  - 12.1 determine and/or amend, by addition to, subtraction from or variation of, these Terms and Conditions without prior notification, including but not limited to the eligibility terms and criteria, the selection of Winners, and the timing and venue of any act to be done, and all Eligible Customers shall be bound by these determinations and/or amendments; and
  - 12.2 vary, withdraw, cancel or invalidate any chances allotted, or substitute, withdraw or cancel any prize without prior notice and without having to disclose any reason therefore and without any payment or compensation whatsoever.

The decisions of UOB on all matters relating to the Promotion are final, conclusive and binding on all Eligible Customers and no correspondence, whether relating to the allotment of chances or otherwise, will be entertained.
