

**Shop & Win A Holiday with UOB 0% Instalment Plan at Harvey Norman
Lucky Draw Terms and Conditions**

1. Eligibility

- 1.1 The United Overseas Bank Limited ("UOB") Shop & Win A Holiday with UOB 0% Instalment Plan at Harvey Norman Lucky Draw ("the Draw") is open to all eligible UOB Credit Card customers as herein described.
- 1.2 Subject to the provisions herein and in particular, Clause 1.3, "Eligible Customers" shall mean all UOB Credit Cardmembers ("Cardmembers") having UOB Credit Card accounts (collectively referred to as "Accounts") which are valid, subsisting and in the sole opinion of UOB, in good standing.
- 1.3 Notwithstanding anything herein, UOB has the absolute discretion at any time and from time to time to determine the eligibility of any customers and shall not be obliged to give any reason therefore. Without limiting the generality of this clause, the following persons are not eligible:
- i. Staff or Directors of United Overseas Bank Ltd and Pertama Merchandising Pte Ltd during the Qualifying Period (as hereinafter defined);
 - ii. Cardmembers whose principal Account(s) is/are terminated between 21 July 2008 and the Draw Date (both dates inclusive);
 - iii. Cardmembers who are or become insane, deceased, or insolvent;
 - iv. Cardmembers who face legal proceedings or any threat of legal proceedings;
 - v. Cardmembers whose accounts are otherwise determined by UOB in its absolute discretion as being delinquent or unsatisfactorily conducted for any reason; and
 - vi. Any other person as UOB may decide to exclude at its sole and absolute discretion and without any notice and without furnishing any reason.

The above persons shall be disqualified and shall not be entitled to any payment or compensation whatsoever, even if he or she has been selected to be a winner of the Draw.

This promotion is not applicable to UOB JCB card, ONE Card MasterCard, Bank 121 Card, Travel Accounts, Purchasing and Private Label Card.

2. Dates

The Qualifying Period for this Promotion commences on 21 July 2008 and ends on 28 September 2008 (both dates inclusive).

3. Allocation of Chances

- 3.1 1 Lucky Draw chance will be awarded for a charged amount of S\$2,000 and above to a UOB Credit Card via UOB 0% Instalment Payment Plan at any of the 14 Harvey Norman outlets during the Qualifying Period.
- 3.2 Cardmembers must complete the Lucky Draw Form, attached together with their UOB charge slip and drop it into the UOB Lucky Draw Boxes located at the Cashier Counters in all Harvey Norman outlets within the Qualifying Period to qualify for the Draw. Only one UOB charge slip can be attached to one Lucky Draw Form.
- 3.3 Lucky Draw Forms that are incomplete and/or without the attached UOB charge slip will be deemed as disqualified.

- 3.4 UOB's decision on the total number of chances allocated to an Eligible Customer shall be final and conclusive.

4. Draw Dates

- 4.2 UOB reserves the right to draw reserve winners to substitute any winner subsequently found to be disqualified. UOB's determination of the winners shall be final, conclusive and binding. No correspondence or claims will be entertained.

- 6.3 These Terms and Conditions shall be governed by the laws of Singapore, and all Eligible Cardmembers who participate in the Draw shall be deemed to have agreed to submit to the non-exclusive jurisdiction of the Singapore Courts.
