

TERMS AND CONDITIONS GOVERNING THE YOUNG PROFESSIONALS SOLUTION SURVEY PROMOTION ("TERMS AND CONDITIONS")

- 1. This Young Professionals Solution Survey Promotion (the "**Promotion**") is only valid between 1 June 2017 and 30 June 2017, both dates inclusive ("**Promotion Period**").
- 2. This Promotion is only applicable to individuals who have successfully fulfilled <u>all</u> of the following conditions (each an "Eligible Customer" collectively "Eligible Customers"):
 - a. completed and submitted the online Young Professionals Solution Survey Form ("**Form**") to United Overseas Bank Limited ("**UOB**") within the Promotion Period. Incomplete Forms will not be accepted; and
 - b. have an existing UOB YP Sweep Account, which is active, valid, subsisting or in good standing or which are otherwise determined by UOB.

UOB and the participating Fund reserve the right to vary/amend the terms and conditions without prior notice or giving any reason or being liable to any person. No correspondence appeal or claims will be entertained.

If any Eligible Customer is subsequently discovered to be ineligible or not entitled to participate in the Promotion or to receive the Award, UOB reserves the right to forfeit the Award and grant or dispose of it in such manner and to such persons as UOB deems fit without any liability on the part of UOB to any persons. - 13. In the event of any inconsistency or discrepancies between these Terms and Conditions and any brochure, marketing or promotional material relating to the Promotion, these Terms and Conditions will prevail.

UOB shall not be liable if it is unable to perform its obligations under these Terms and Conditions, due directly or indirectly, to the telecommunication authorities, to any machine, computer or communication system, to any merchant, or service provider or such other third party which maybe engaged for the Promotion, industrial dispute, war, Act of God, or anything outside the control of UOB.
